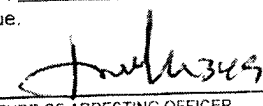
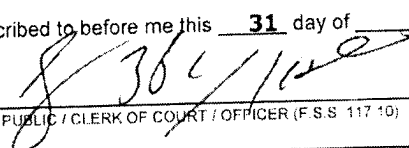

N A R R A T I V E	10/5/83). Stevens advised she was involved in a physical altercation with her boyfriend of 1 year Taylor R. Yett (W/M 7/23/92) at 2187 Marcinski Rd (South Parking Pod) at approximately 0230 hours. I obtained a sworn statement from Stevens and it stated the following: Stevens advised Yett is currently homeless so she went with him to the beach at 0030 hours. Stevens stated they were hanging out in her vehicle a red SUV bearing FL Tag #640RAG. At approximately 0230 hours Yett began to become belligerent and started to talk bad about Stevens family because they kicked him out of their home. Stevens stated while Yett was talking bad she tried to calm him down. Stevens stated Yett was smoking a cigarette and he put the cigarette out on her leg causing a small burn mark on her upper right thigh. When that happened Stevens stated she got out her vehicle and Yett did too. Stevens stated she started to cry but he was still belligerent. Stevens looked at her phone to look at the time and Yett came over and grabbed it out of her hands. Stevens stated he then smashed the white Iphone on the ground. After Yett did that, Stevens stated he then broke a piece of her roof rack off and used it to smash the tail lights of her vehicle. He then hit the passenger side mirror with it. Stevens stated he then slashed her rear passenger tire with a knife. Stevens advised he did not threaten her with the knife. Stevens stated she was able to calm Yett down to the point that she was no longer in fear of him. Stevens advised she waited till today to make a report because she had to get her tire fixed and did not have a phone. Stevens advised there is approximately \$2000 dollars' worth of damage between her vehicle and her phone. I attempted to get into contact with Yett several times via phone and each time his phone went to voicemail. Stevens advised Yett is homeless and he frequents several places in Palm Beach County but was unable to give an exact location. I took pictures of Stevens injuries and the damage to her belongings with my department issued phone. Stevens still had a burn mark on her right leg from the cigarette. Stevens refused to be seen by fire rescue. Based on my above-described investigation, Yett did knowingly take away Stevens phone with the intent to permanently or temporarily deprive Stevens of her phone, contrary to Florida Statute 812.131 (2)(b). Yett did actually and intentionally touch or strike Stevens with a cigarette causing a minor burn to her right leg, contrary to Florida Statute 784.03(1). Yett also did unlawfully, willfully and maliciously, damage Stevens vehicle and her cellphone, contrary to Florida Statute 806.13(1)(B)(3). I issued Stevens a Domestic Rights Brochure. On 8/2/19, I was able to get into contact with Yett via phone. I asked Yett, if he was able to meet with me and he responded stating he has no means of transportation to meet. I asked Yett about what had occurred, Yett was not descriptive about the incident that occurred on 7/31/19 with Stevens and he just said Stevens was going crazy. While speaking with Yett, he advised he had bad phone reception and during the phone call the call dropped. I attempted several times to call Yett back but the phone went to voicemail. Due to not being able to receive a sworn statement from Yett about what occurred on 7/31/19 and his statement over the phone, charges will be filed with the State Attorney's Office.
