DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time while conducting traffic enforcement along the 12600blk Southshore Blvd Wellington, FL I noticed a lone vehicle approaching from the rear of my patrol vehicle at a high rate of speed. I estimated the vehicle speed at 60mph. My Stalker DSR2 radar unit gave a crisp clear doppler tone consistent with a vehicle traveling at 60mph. The LCD display showed a vehicle speed of 60mph in a 45mph zone. I caught up to the white Range Rover after it passed me. I activated my emergency lights and the vehicle turned into the left turn lane. The vehicle continued into the gated community of Polo Club. The vehicle came to a stop at the 4 way intersection of Polo Club RD/Polo RD W. The vehicle tag is 619RCL.

### OBSERVATION OF DRIVER:

I made contact with the def who was the lone person in the vehicle. I noticed that the def had glassy eyes and an odor of an unk alcoholic beverage coming from her person. I asked the def for her license, registration and insurance. The def provided me with her license and showed me her insurance card on her cell phone. The def fumbled around in her glove box looking for her registration. The def was unable to provide me with her registration. I asked the def where she was coming from and she stated The Grille where she works. I asked the def if she had anything to drink tonight and she stated yes that she had two glasses of champagne over the last couple of hours. The def was asked to step out of the vehicle. I noticed that the def had a odor of an alcoholic coming from her breath. The def was swaying while standing still. The def was notified I was conducting a DUI Investigation and asked her to submit to SFST's. The def stated that do I want the truth. I stated yes I love the truth. The def stated that she had two drinks at work and was on her way home and that she made a mistake. The def stated that she only works 2 1/2 miles away and that she should have never driven since she is impaired. The def stated that




