D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was dispatched to 1213 S. D. St. in reference to a vehicle accident. Upon my arrival, I observed a Hispanic male wearing a white shirt and black gym shorts standing next to a white four-door vehicle, bearing Florida tag Y27ENP. He identified himself as Telesaro Vasquez, the registered owner of the vehicle. He stated that he was the sole occupant in his vehicle and he was driving his car northbound on S. D. Street. when his girlfriend flagged him down in the street. He stopped and she began to try to hug him through the car window, when he lost control of the vehicle. The front right side of his vehicle struck the front right side of a black, four-door vehicle parked facing southbound on the west side of the street. Telesaro handed me his registration, insurance and keys to the vehicle, but stated he does not have a driver's license.

OBSERVATION OF DRIVER:

As I spoke with Telesaro, the odor of alcohol emanated from his mouth. He struggled to stand up straight, staggering in small circles while I spoke to him about the crash. His eyes were bloodshot and his speech was slurred. Any time I asked Telesaro a question, there was a slight delay before he would respond to me. Telesaro would stare off into the sky and I would have to verbally get his attention again to get him to focus on my questions.

DRIVER'S STATEMENTS:

Telesaro confirmed he was driving the vehicle, and was trying to go home after visiting his girlfriend's house for Thanksgiving. Telesaro was unable to provide the proper spelling of his name nor was he able to provide me with the year of his date of birth. He questioned himself, stating "I think I was born in 1994, or maybe 1984?" Telesaro stated he is normally a red wine drinker, but he had drank two Coronas at his girlfriend's house prior to leaving her residence.

ODORS:

The odor of alcohol emanated from Telesaro's mouth. After removing Telesaro from my patrol car, I could smell the odor of alcohol permeating the interior of the prisoner cage.

ROADSIDE TASKS

HORIZONTAL GAZE NYSTAGMUS:

Other Observations:

Telesaro struggled to follow directions on all roadides. He repeatedly attempted to begin the task while I was still giving instructions. Telesaro would state that he understood the task asked of him, but once he began it and failed, he would ask for instructions again and state he didn't remember what to do.

WALK & TURN:

Telesaro failed to maintain the instructional stance. He swayed back and forth, waving his hands around in the air keep his balance. He did not keep a heel to toe stance nor did he touch his heels to his toes as he walked. Telesaro took more than 9 steps in both directions. He failed to turn around properly, shifting his feet in a 180 degree direction instead of as instructed. Telesaro continually looked at me for approval or instruction on when to stop, despite already being told when to do so prior to the start of the task. He also failed to count out loud as instructed.

ONE LEG STAND:

Telesaro failed to wait for instructions to begin the task. He did not lift his foot approximately 6 inches off the ground as instructed. On his first try, he would hold his foot above the ground momentarily before taking a few steps and then starting again. He asked for another chance at the task, and I re-explained the instructions. He again failed to complete the task properly. Telesaro did not count in order, skipping numbers and counting from 1-10 repeatedly instead of in order from 1 until I asked him to stop. He asked multiple times if he was done, rather than counting until advised to stop.

FINGER TO NOSE:

Telesaro failed to wait for instructions to begin the task. He struggled to mimic the instructional stance and had to be shown multiple times how to do so. He attempted to tilt his head back and touch his fingers to his nose while I was still giving instructions. When asked to touch his left finger to his nose, he touched his right finger instead. He held his finger to his nose and did not return his hand back to his side immediately, as instructed. Multiple times, he would return his hands all the way down at his sides instead of halfway down as instructed.

ROMBERG ALPHABET:

Telesaro stated he speaks English fluently, but when asked if he knew the entire alphabet, he stated he only knew some. He stated he did not know the Spanish alphabet, but was able to count to 20 in Spanish. Telesaro tilted h head back and closed his eyes, but counted past 20 and had to look at me for confirmation to stop counting instead of ending at 20 as instructed.


