On the **20** day of **April**, **2018** at **18:47** (Specifically include facts constituting cause for arrest.)

On 04/20/2018 at approximately 1759 hours, Ofc Murphy and I were dispatched to 8 Forest Hills Ln in reference to a domestic trouble.

Upon arrival, Ofc Rafalko was standing by with a W/F, later identified as Teresa Pugliese, and W/M, later identified as Andre Pugliese.

I spoke with Andre first who stated he and his sister (Teresa) were driving with a friend's on NW 2nd Ave when they stopped at their friends work, 1356 NW 2nd Ave, to get his paycheck. According to Andre, Teresa was seated in the front passenger seat and he was in the back rear passenger seat waiting for their friend in the parking lot. Andre stated Teresa became angry with him over a past issue and started calling him names. Andre explained that is when the argument escalated out of control. According to Andre, Teresa started pinching his belly and calling him a "fat piece of shit". Andre stated Teresa kicked him and burned him on his right knee with her lit cigarette. Andre stated that is when he got out of the car and tried to get his money back (that he had given to her earlier in the day) because of the argument. Andre explained Teresa jumped on him and started hitting him as he was reaching for a green bag that he believed the money was in. Andre explained that is when Hank Schiffer (a mutual friend of both Teresa and Andre) came over and broke up the fight by stepping in between them. I observed a cigarette burn to Andre's leg (photo was placed into evidence).

Next I spoke with Teresa. Teresa explained that she and her brother were parked in a parking lot but was not sure which one. According to Teresa, she and Andre got in an argument over some Publix gift cards that he had given her. Teresa was unable to provide any statement about any physical altercation that occurred within the vehicle and denied all the allegations. She did state that she had grabbed Andre's stomach and called him "fat boy," but was unable to explain when that occurred. Teresa stated she



was unsure how or why she got out of the car. Then Teresa stated she was pulled out by her hair by Andre. Teresa stated she "just wanted to be left alone and wanted to talk with her lawyer". This ended my question with Teresa failing to dispel Andre's statements. It should be noted I observed no visible evidence that would suggest Andre pulled Teresa's hair.

Based on statements made by Andre and visible injuries to his right knee, Teresa was placed under arrest under FSS 784.03 Simple Battery /Domestic. She was transported to BRPD booking and then TOT CJ.
