NARRATIVE:

I was dispatched to 15956 D Arlene Drive, within unincorporated Delray Beach in reference to a domestic dispute.

Prior to my arrival, my dispatcher told me that the complainant who was later identified by Florida Drivers license as Damian McFadden, called 911 because his daughter who verbally identified herself as Jessica Grover and his ex-wife who also identified herself as Teri McFadden were physically fighting in the house.

Upon my arrival to the residence, Damian and Jessica were sitting outside of the house on a bench and Teri was inside of the house with her and Damian's eleven year old autistic son who was verbally identified as Jaden McFadden.

Damian stated he and Teri are currently separated and that he rushed to his house when he received a call from his step daughter Jessica, who stated that she needs assistance with Teri because she was drunk and verbally arguing with her. When Damian arrived on scene, he said that her current boyfriend who verbally identified himself as Sherif Abdellatif, was leaving the house. He said that Teri began arguing with him and Jessica about why they were at home and accusing Jessica of taking Damian's side during the separation. He said that he saw Teri head-butt Jessicas's forehead with her forehead and swing her arm toward Jessica as if she was going to punch her in the face. At that point, Jessica tried to defend herself and pushed Teri back but Teri kept lunging toward Jessica in an attempt to hit her again. They both fell to the ground and that's when Damian decided to call 911. He eventually pulled them apart and he waited outside with Jessica on our arrival. Damian said that Teri suffers from anxiety and mental issues and has been Baker Acted several times in the past and is an alcoholic.

I then spoke with Jessica who stated that she received a phone call from her mother's boyfriend of one month Sherif, and he asked her if she could go to the house because he felt that Teri should not

be alone because she fell earlier and hit her head. She said that she immediately knew what that meant, and decided to go to the house to watch Teri and Jaden. She stated that her mother Teri constantly drinks alcohol and is what she called a functioning alcoholic and she falls often because she is unable to walk steady when she is drunk sometimes. When she arrived on scene, she said that Teri had some scratches on her head from the fall and when Teri saw her, she began to argue with her. Teri told her to get out of the house and telling her that she was not allowed to be there because she is taking Damian's side throughout the separation. She said that Sherif has not been with Teri long enough to understand that she gets drowsy when she has been drinking. She called her father Damian to help and when he arrived, Sherif left the house and Damian and Teri began to argue. At one point during the argument, Teri head-butted Jessica's head and when Damian tried to interfere, Teri went around him and hit the right side of Jessica's right cheek with her left fist. When Jessica tried to push her back, she lunged at her more times until they both fell to the floor. Jessica said she tried to push Teri off of her and punched her back to get away. When Damian stepped in to help, they both went outside to avoid any further incident. Her sworn statement was recorded. I observed a red mark on Jessica's cheek and a mark on her right knuckle. She was photographed for evidence.

I then spoke to Teri who stated that Jessica came over unannounced and began arguing with her because she had a new boyfriend Sherif. She said that she fell earlier but that Jessica beat her up. She said that as they were arguing, Jessica started to hit her multiple times. She was very brief and did not explain in detail the events leading up to the incident. She said that she believes that Damian and Jessica are treating her unfairly because she has a new boyfriend. She had several scratches and bumps that were bleeding. She refused medical attention but they arrived on scene to look at her injuries. She was photographed and her statement was recorded.

Based on my investigation, physical evidence and the sworn statements, I determined that Teri was in violation of F.S. 784.03(1)(A)(1) Battery-Domestic related because he did actually and intentionally touch or strike Jessica against the will of Jessica or did intentionally cause bodily harm to Jessica and Jessica was a family or household member of Teri.
