NARRATIVE:

On 10/16/2019 Deputy Stephan Roberts #6509, while working the front desk of the PBSO District 8 Wellington Sub-station, met with walk in complainant/victim Tony Doan in reference to a report of Grand Theft and a possible Construction Fraud investigation. The victim advised that on 4/10/2019 he initiated contact, with who he believed to be a licensed contractor, Terrance Powers (w/m 03/03/1964) owner of Unlimited Interior & Exterior Improvement Services, Inc. Powers was recommended to Doan by a neighbor who utilized Powers to complete a painting service in the past. Doan believed Powers to be licensed as Powers presented Doan with a written estimate in the name of his business, Unlimited Interior & Exterior Improvement Services, Inc., and Powers had completed work for his neighbor. Doan negotiated a deal with Powers to paint his home for \$2,700.00. Doan was asked by Powers to provide a deposit of \$1,700.00 in advance of the services, an amount exceeding 10 percent of the contract price. Powers was to pull any required permits and begin work at a later date. Doan wrote Powers a check, #2814, drawn on Doan's business account at Bank of America (N D Investment Enterprises, Inc) in the amount of \$1,700.00, dated 4/10/2019 made payable to Terry Powers. That check was cashed, the same day, 4/10/2019.

The victim attempted to schedule a start date with Powers, however, they were told by Powers that due to rain delays he (Powers) was backed up and he would contact them and let them know when he could begin work. After several failed attempts over the next several weeks, to reach Powers and schedule a start date, the victim contacted his neighbor, Ed Neely, who had recommended Powers to him. Neely was able to reach Powers and advised he would start painting the following week. Powers never started the work and over the next several months never returned any of the victim's phone calls. As a result, the victim has sustained a loss of \$1,700.00.

The laws of Florida and Palm Beach County require a Contractor to have a license (Certificate of Competency) to bid, contract or perform work in numerous regulated trades to include the trade of Painting. Contractors must be licensed as State Contractors (allowed to work statewide) or County Contractors (only allowed to work in the county they are licensed /certified in).

NARRATIVE CONTINUATION

When a contractor is not licensed or certified by the county or state they are considered an Unlicensed Contractor. They cannot apply for permits nor have someone else apply for the permits for them.

On 10/23/2019 I sent a subpoena to Bank of America reference the victim's check # 2814. It was later confirmed that Terrance Powers, DOB 03/03/1964, negotiated the check on 4/10/2019 against his Bank of America account.

On 10/25/2019 Detective D. Murray assisted with the presentation of a photo lineup to victim Tony Doan. Doan was able to make a positive identification of suspect Terrance Powers.

Doan sent the statutorily required demand letter, sent certified letter, return receipt requested, to suspect Powers demanding repayment of the \$1,700.00. Per FSS requirement, the suspect had 30 days to refund the payment.

On 11/12/2019 I met with Victim Doan who presented to me the certified letter he mailed, return receipt, to the suspect, Terrance Powers on 10/25/2019 to his address on file (Sunbiz.org) at 13525 Brixham St, Wellington, FI 33414. The letter was returned Return to Sender, Not Deliverable as Addressed, Unable to Forward.

On 11/14/2019 I contacted The Department of Business and Professional Regulation (DBPR) and spoke with Ed Garcia, Southeast Region Field Manager for Division of Regulation. He advised, after a diligent search of the Department of Business and Professional Regulations electronic records, there is no evidence that the suspect in this case, Terrance Powers, ever had a current or active license as a Construction Contractor in the State of Florida. He also advised the same for Unlimited Interior & Exterior Improvement Services, Inc. He later provided the two Certificates of Non-Licensure from DBPR. A search of PBC Building Division shows no painting permit was pulled.

I also contacted and received a letter from CILB (Construction Industry Licensing Board) advising that there is no evidence that Terrance Powers had any type of Contactor License from the CILB from 2005 - Present. The CILB also provided records that Suspect Terrance Powers had been issued a citation from CILB for contracting as a Painting contractor without certification in 2005 and 2008.

Based on this investigation and the facts as presented, probable cause exists to charge and arrest Suspect Terrance Powers with Grand Theft (a violation of FSS 812.014 (2)(c)(1) as the victim paid suspect Powers \$1,700.00 for services, which had not been performed for a period of over 90 days, depriving the owner of the funds and inferring the suspect appropriated the funds for his own use), and Contracting Without Certification (as upon search of the Contractors Certification Division records, no certification was discovered for Terrance Powers, d/b/a Unlimited Interior & Exterior Improvement Services, Inc., to engage in the regulated trade of Painting Contractor in Palm Beach County; therefore, the contractor is in violation of FSS 489.127 (1)(f) by engaging in the business or acting in the capacity of a contractor without being duly registered or certified or having a certificate of authority).
