### FAILURE TO SUBMIT TO A BREATH, URINE, BLOOD TEST FOR BUI

### PROBABLE CAUSE

On July 29, 2017 at approximately 2059 hours, I, Officer Stephen Spradling with the FWC (Florida Fish and Wildlife Conservation Commission) was dispatched to a call of a possible impaired vessel operator that came in from the United States Coast Guard. I arrived on scene to New Port Cove Marina on the ICW at approximately 2121 hours. Coast Guard advised they witnessed Mr. Terrence Mancel McManus operating his vessel (FL2548NB) with no navigational lights on at alcohol and witnessed him swaying back and forth. He was having a difficult time understanding and answering questions. His eyes were blood shot red and glossy. Mr. Mcmanus was also slurring parts of his speech.

Mr. McManus consented to performing seated field sobriety tasks. On Horizontal Gaze Nystagmus Mr. McManus Showed 6 clues. On Finger to nose Mr. McManus was not following instructions and had 19 clues. On the Palm Pat task he struggled following instructions. I would ask him if he understood and he would respond "thank you". He showed 4 clues on the Palm Pat task. On the Hand Coordination task Mr. McManus was not able to follow instructions and showed 6 clues. Due to United States Coast guard witnessing Terrence M. McManus operating his vessel and my training and experience indicating impairment, I placed Mr. McManus under arrest for BUI. Mr. McManus was transported to Palm Beach County Jail where he refused to submit to breath, urine or blood testing. Mr. McManus was cited for BUI and Refusal.



