**PERSONAL CONTACT**

**NARRATIVE:**

On 03/31/2017 at approximately 1800 Hours I responded to 3121 Lake Worth Rd. Palm Springs FL 33461 in reference to a Domestic Battery which occurred at 421 Talia Cir. Palm Springs FL 33461.

Upon arrival I met with Mclean Thompson (Victim) who was visibly upset, had several visible bruises and red marks on his neck, arms and left leg. The collar of his t-shirt was also stretched out as if someone had pulled it. Thompson advised he recently made the decision to separate with his husband (Terrence Narinesingh) and moved all of his belongings out of the house today while Narinesingh was at work. Thompson advised he waited for Narinesingh to come home from work to let him know that he was separating with him and moved all his belongings out of the house. Thompson advised once Narinesingh arrived home he and Narinesingh verbally argued for approximately 1 hour. Thompson advised he was admit about leaving and began to leave the residence.

Thompson advised the verbal argument escalated and got physical when Narinesingh lunged at him when he began to leave. Thompson advised Narinesingh grabbed the collar of his shirt and pushed him up against the wall several times as he tried to leave. Thompson advised he was able to leave the residence once he got away from Narinesingh, this is when he called 911 and went to 3121 Lake Worth Rd. Palm Springs FL 33461 to wait for PSPD's arrival. Thompson stated he during the struggle he received several burses on his arms and left leg.

Thompson and I then went back to his residence (421 Talia Cir. Palm Springs FL 33461) where I met with Narinesingh. Narinesingh advised he returned home from work and met Thompson in the living room where he was waiting for him. Narinesingh advised Thompson stated he moved all this things out of the residence and was going to leave him. Narinesingh advised he was concerned that Thompson packed up some of his belongings and began to argue with Thompson. Narinesingh advised he pled for Thompson to reconsider and at least sleep in a separate bedroom for the night, but Thompson was instant on leaving. Narinesingh advised during the confrontation Thompson had his dog in his lap and Narinesingh advised him that the dog belonged to him and demanded that he keep his dog and they began to fight for the dog (pulling it back and forth). Narinesingh advised during the struggle he may have grabbed Thompson's shirt, which caused it to stretch out. Narinesingh advised he finally got his dog in his possession and Thompson left the residence.

Thompson made no mention of a struggle for possession of the dog, advised that the dog belonged to Narinesingh and he had no intention of taking the dog other wise he would have taken it earlier when he packed all his belongings. Thompson provided a Sworn Video recorded statement and photographs of his injuries were taken. Both were submitted into PSPD Evidence.

Based on physical evidence and statements given be both parties Narinesingh was place under arrest (Placed in handcuffs to the rear, checked for proper spacing, and double locked) for Domestic Battery F.S.S. 784.03 (1)a(1) and transported to PSPD holding cell where the necessary paper work was completed. Then transported to Palm Beach County Jail for processing.

DEFENDANT'S STATEMENTS: (Written  / Taped  / Oral )

Narinesingh advised he returned home from work and met Thompson in the living room where he was waiting for him. Narinesingh advised Thompson stated he had moved all this things out of the residence and was going to leave him. Narinesingh advised he was concerned the Thompson packed up some of his belongings and began to argue with Thompson. Narinesingh advised he pled for Thompson to reconsider and at least sleep in a separate bedroom for the night but Thompson was instant on leaving. Narinesingh advised during the confrontation Thompson had his dog in his lap and Narinesingh demanded that he keep the dog and they began to fight for the dog (pulling it back and forth). Narinesingh advised during the struggle he may have grabbed Thompson's shirt which caused it to stretch out. Narinesingh advised he finally got the dog in his possession and Thompson left the residence.

**VICTIM'S STATEMENTS:** (Written  / Taped  / Oral ):

Thompson advised he recently made the decision to separate with his husband (Terrence Narinesingh) and moved all of his belongings out of the house today while Narinesingh was at work. Thompson advised he waited for Narinesingh to come home from work to let him know that he was separating with him and moved all his belongings out of the house. Thompson advised he and Narinesingh verbally argued for approximately 1 hour while Narinesingh was trying to reconcile their marriage; However, Thompson advised he was admit about leaving. Thompson advised the verbal argument escalated and got physical when Narinesingh lunged at him when he began to leave. Thompson advised Narinesingh grabbed the collar of his shirt and pushed him up against the wall several times as he tried to leave. Thompson advised he was able to leave the residence once he was able to get away from Narinesingh, this is when he was able to call 911 and went to 3121 Lake Worth Rd. Palm Springs FL 33461 to wait for PSPD's arrival. Thompson stated he during the struggle he received several burses on his arms and legs.
