Glades Road(Sears) in reference to a shoplifting in progress. Sears LPO Robert Leach called BRPSD communications center to advise that a W/F with brown hair wearing a blue top, blue skirt and carrying a red purse just stole several items from the store and was walking out of the store through the north entrance/exit.</p> <p>Upon arrival, Ofc. Finne ID#756 and I made contact with the W/F, who was later to be known as W/F, Theresa Brown, 3/3/1958 in the north parking lot of Sears. We took her into custody and brought her back to the Sears LP Office where we met with LPO Leach. Leach advised that he observed Brown on cctv camera enter the jewelry and electronics department, take items off the shelves and place them in a shopping cart. She then went into the fitting room for approximately one minute then exited. He stated that the red purse she was carrying was no longer flat and none of the items she selected were inside the fitting room after she walked out. He then stated that she exited the store, passing all points of sale, making no effort to pay for the concealed merchandise. Leach completed a sworn written statement that was submitted into evidence. Leach informed me that a copy of the cctv video will be available by Sunday 10/23/2016. Inside her purse we found a silver necklace, a pair of clear stone earrings and a tablet. All items are listed separately in the property section of this report. The total cost of all the items is \$629.95</p> <p>I then advised Brown of her Miranda rights and she advised that she understood them and that she wanted to talk with me. She admitted that she took the items listed above because she is out of work and needed money. It was at this time that I advised her that she was being placed under arrest for shoplifting.</p> <p>My investigation revealed that W/F Theresa Brown 3/3/58 was in violation of FL. State Statute 812.014(2c1) when she took the merchandise from Sears passing all points</p>
