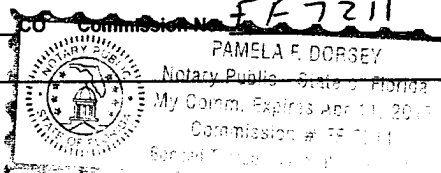

Driver was pulled over by Sergeant Lally for speeding. See Supplement narrative

OBSERVATION OF DRIVER:

Verbally aggressive, will not listen to the officer, odor of alcohol emanating from his breath. Swaying with or without assistance of cane. Glassy and bloodshot eyes.

DRIVER'S STATEMENTS:

Advised he tipped 100 dollars on a 50 dollar tab at square grouper in Jupiter. Stated he had 4 drinks, but later changed it to 2 margaritas. Was verbally aggressive and would not let the officers talk. Made remarks saying that we were treating him as if he was a "terrorist". MEDICAL/OTHER: Stated he has screws in his left leg and needs cane to walk after he uses the bathroom

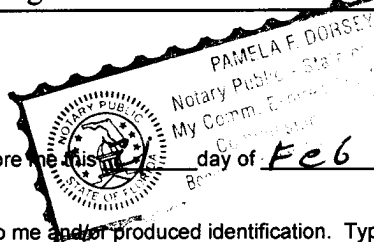

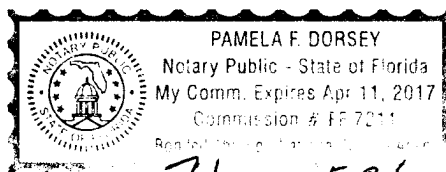


