On the 10 day of June, 2018 at 01:50 (Specifically include facts constituting cause for arrest.)

On 06/10/18 at approximately 0122 hours, I observed a white 2014 Mercedes SLK 250 bearing Illinois tag # AM49761 fail to stop at the stop sign making a right turn from SE 2nd St onto S Dixie Hwy causing a vehicle in the far-right lane to press his brakes to avoid colliding into the vehicle. I conducted a traffic stop on the driver of the white Mercedes and came to a complete stop at 100 W Palmetto Park Rd. I made contact with the driver W/M Thomas Allen and the front seat passenger W/F Sara Rzepkowski.

Upon speaking with Allen, I detected the strong odor of alcohol emanating from his breath. He had slowed slurred speech while I made conversation with him. I asked him if he had anything to drink this evening to which he stated, "I had one beer". His eyes were bloodshot and watery. Officer Renteria arrived on scene as my back up officer.

I explained to Allen my observations and requested that he perform several field tasks in order to dispel my alarm that he had been driving impaired. He stated he would take part in the tasks. He stated before beginning the tasks that he did not have any physical disabilities that would keep him from performing the tasks.

The first task with the horizontal gaze nystagmus. He was swaying side to side while standing. There was a lack of smooth pursuit in each eye. I had to remind him not to move his head while following the pen with his eyes. There was distinct and sustained nystagmus at maximum deviation in each eye. Onset of nystagmus prior to 45 degrees in each eye.

The second task was the walk and turn. He started before he was instructed. He left the starting position. He did not touch heel to toe on each step while walking down the line. He did not turn as instructed. He did not touch heel to toe on each step returning down the line either.

The third task was the one leg stand. His foot was not 6" from the ground. He was using his arms for balance and swaying. He kept dropping his foot on the ground to keep his balance. He forgot the instructions a few seconds into the task and had to be reminded to continue until I give him the command to stop.

The fourth task was the finger to nose (L-R-L-R-R-L). He was swaying side to side at times. On the third right hand command, he moved to lift his left hand but switched to using his right hand to touch his finger to his nose.

The fifth task was the Rhomberg alphabet. He was swaying back and forth at times. He recited the alphabet quickly and in a rhythmic manner.

At 0150 hours, I placed Allen under arrest. His personal items and vehicle were turned over to his girlfriend Rzepkowski.

Officer Murphy conducted The Intoxilyzer 8000 testing. He refused to give a sample of his breath. He was read implied consent and again refused to give a sample of his breath.

Allen was charged with DUI FSS 316.193(1). He was also cited for failing to stop at a stop sign, failure to provide proof of insurance and given a written warning for having an expired registration. He was given the court date of 07/09/2018 at 8:30am. The in-car video was submitted into property. After processing, he was transported to the Palm Beach County Jail.
