D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I observed a white in color 2017 Kia Optima bearing FL Tag IMCI92 traveling west on SR 706 (W Indiantown Rd) preparing to turn north onto SR 811 (N Alt A1A) in Jupiter FL. The vehicle turned north and did not maintain its lane through the turn. While traveling north on SR811 the vehicle failed to maintain its lane and crossed the white dotted lines on both sides of the lane. The vehicle then turned onto E. Riverside Drive and continued to the US 1 intersection. At the E. Riverside Dr/N US 1 intersection the vehicle failed to come to a complete stop before the white limit line on the roadway. The vehicle came to a complete stop with all four tires across the line. While going south on N US 1 the vehicle again crossed the dotted white line. At this time I advised Northcom that I would be conducting a traffic stop on the vehicle. I activated my red and blue overhead emergency lights to signal the vehicle to pull over. The vehicle initially slowed to a stop in the turn lane to go west on SR 706 from US 1 just south of Breakwater Dr. The vehicle then began to make the turn and slowly rolled west on SR 706. The vehicle finally came to a complete stop.

OBSERVATION OF DRIVER:

Upon making contact with the driver, who was secured by his seatbelt, I immediately noticed the strong and distinct odor of an unknown alcoholic beverage coming from inside the vehicle. I positively identified the driver as W/M Thomas J. Cognetti (09/09/1960) by his Florida Drivers License. Cognetti had glassy eyes and at times had slurred speech. While speaking with Cognetti the odor of an unknown alcoholic beverage grew stronger. Cognetti was confused throughout the encounter. When Cognetti exited the vehicle he utilized the door to balance. Cognetti was swaying while standing still.

DRIVER'S STATEMENTS:

Cognetti stated that he was coming from his house when I initially asked him where he was coming from. I asked Cognetti where he was going and he again said his house. Cognetti eventually stated he was dropping off his son and then going home. I asked Cognetti how much he had to drink tonight and he stated nothing but had a glass of wine earlier in the night. I asked Cognetti on a scale of 1-10 with 1 being completely sober and 10 being the most drunk hes ever been in his life, where he thought he was. Cognetti stated about a 2. I asked Cognetti if he thought he was ok to be driving and he stated yes.

Odor of an unknown alcoholic beverage



Other Observations:

WALK & TURN:

Cognetti stated he understood the instructions. Cognetti failed to maintain the starting position and started early. Cognetti failed to properly touch heel to toe on each and every step. Cognetti stepped off line several times. Cognetti conducted an improper turn (turned right and did not use a series of small steps). On the walk back Cognetti again failed to touch heel to toe properly on each step. Cognetti again stepped off line slightly placing his feet side by side instead of directly in front while walking.

ONE LEG STAND:

Cognetti stated that he understood the instructions. Cognetti only went to six seconds the first time he attempted the task. Cognetti was reexplained the instructions and again stated that he understood. Cognetti placed his foot down several times and failed to watch his elevated foot as he counted. Cognetti was struggling to maintain his balance throughout the task.

FINGER TO NOSE:

Cognetti closed his eyes and tilted his head back early during the instruction phase. Cognetti was told to not begin until he was told too. Cognetti again closed his eye early. Cognetti missed the tip of his nose on the first right and touched near the bridge of his nose. Cognetti made very exaggerated movements throughout the task.

ROMBERG ALPHABET:

Cognetti closed his eyes and tilted his head back early even after being told to wait until told to begin. Otherwise Cognetti completed this task without any further issues.


