

The arrestee was asked to leave Mojitos because he was intoxicated. Once outside the establishment Rhenburgh had a glass bottle in his hand. The victim told me Rhenburgh threatened him with the glass bottle then subsequently smashed the bottle on the sidewalk. When he smashed the bottle on the sidewalk glass shards hit the witness in the ankle. The victim and witness gave a statement on Detective Ryan Brust's BWC. The arrestee's actions made the victim fearful for his safety and he wishes to prosecute for simple assault per Florida State Statute (F.S.S) 784.03. Furthermore upon my arrival there was a crowd forming around the arrestee. My observations of the arrestee made me believe he was intoxicated, he had blood shot eyes, the odor of alcoholic beverages were emanating from his person, in addition to making inappropriate comments. Rhenburg's combined intoxication and actions caused everyday patrons to stop and observe him and his behavior. 
