



While en-route Ofc Fabelo advised that Thomas Mulhern was involved in an accident and appeared to be under the influence. Ofc Fabelo advised that Mulhern stated to him that he had been drinking and had about four drinks. Ofc Fabelo advised that Mulhern claimed that he was diabetic and Ofc Fabelo requested BRFD to respond on scene to have Mulhern checked out. BRFD Medic 4 checked out Mulhern and recommended Mulhern be transported to Boca Regional to be checked out further. Mulhern was then transported to Boca Regional (800 Meadows Rd) where I met them.</p> <p>I then met with Ofc Fabelo and he advised that Mulhern had a strong odor of an alcoholic beverage emanating from his person, he was slurring his speech and had blood shot glossy eyes. Ofc Fabelo also advised that when Mulhern exited his vehicle he stumbled back and then went back into the vehicle. Ofc Fabelo when he walked up to Mulhern he was in the driver's side seat asleep. Ofc Fabelo advised that CSO Montenegro completed her traffic crash investigation and gave Mulhern a driver exchange form. Ofc Fabelo stated that the other driver that was involved Olivia Szoarski could place Mulhern behind the wheel of the vehicle as the driver. Szoarski provided Ofc Fabelo a taped and written statement. Both statements were placed into evidence at BRPD.</p> <p>I then met with Mulhern and advised him that the traffic crash had been completed and I would now be conducting a criminal investigation. I then read Mulhern his Constitutional Warnings in the presence of Ofc Fabelo. Mulhern advised that he understood and would answer my questions without an attorney present. Mulhern advised that he backed into another car and he stated that there was minor damage to the cars. Mulhern stated that both parties agreed but then the other party changed their mind and called BRPD. I then asked Mulhern if he had been drinking today and he stated that he had a few drinks. Mulhern would not elaborate on the exact amount and then stated that the attorneys could handle that. I then asked him if he wished to continue speaking</p>

with me and Mulhern stated no.

While speaking to Mulhern I could smell a strong odor of an alcoholic beverage emanating from his person, his eyes were blood shot and glossy and he was slurring his speech. I then asked Mulhern if he would submit to roadside sobriety tasks and he stated no. I then informed Mulhern of his Taylor Warnings and Mulhern advised that he understood. I then asked again if he would perform the roadside sobriety tasks and Mulhern stated no. Based on the above information, I placed Mulhern into custody for DUI at 1637hrs. Mulhern was being checked out at Boca Regional and I spoke with RN Christopher at 1845hrs who stated that it would be an unknown time before Mulhern would be seen by a doctor or even be cleared from the hospital. Due to breath being impractical at this point I then asked Mulhern for a blood sample at which time he refused to provide a blood sample. I then read Mulhern his Implied Consent Warnings and he advised that would not provide a blood sample.

Thomas Mulhern is being charged under F.S.S 316.193(1) for DUI.
