PERSONAL CONTACT

DRIVING PATTERN:

WHILE CONDUCTING PATROL IN THE 700 BLK OF OLD DIXIE HWY, I (OFFICER ANDERSON) OBSERVED A WHITE PICKUP TRUCK TRAVELING SOUTH ON OLD DIXIE HWY AT 60MPH IN A POSTED 40MPH ZONE. I MADE A U-TURN AND BEGAN FOLLOWING THE VEHICLE. I ACTIVATED MY EMERGENCY LIGHTS AT OLD DIXIE HWY AND TEQUESTA DR. THE DRIVER TURNED EAST ON TO TEQUESTA DR AND CONTINUED TO MAIN ST AND TURNED RIGHT ONTO MAIN ST WHERE HE STOPPED.

Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
