### Probable Cause

On the above date and time, Trooper Florangel Cardenas was dispatched to a hit and run traffic crash southbound on State Road 91, south of MM 86. The Lake Worth Regional Communications Center (LWRCC) reported a second vehicle around the 85-mile marker where apparently a domestic was in progress. I advised the LWRCC that I would respond to assist. I first stopped out with Trooper Cardenas' crash, and she then redirected me to what appeared to be a second crash, just south of her location. Upon my arrival I observed a Whit Honda Accord and a gray Masarati parked in the inside shoulder.

Honda was parked in front of the Maserati. I spoke Mr. Christopher G. Pinto, date of birth 2/12/1995, and he advised me that he believed the Maserati was involved in a crash north of our location. When I spoke with the Maserati right front passenger, Mr. Richard L. Rockefeller, date of birth, 09/09/1984, he advised that Mr. Pinto threaten to shoot him in the neck. He further advised that he thought he saw Mr. Pinto pulled out a firearm but later realized it was a cellular phone. He stated that he did not want to file any charges and Mr. Pinto departed the scene. Mr. Rockefeller advised that Ms. Prodey was driving the vehicle at the time of the crash. He put Ms. Podray behind the wheel. After I spoke with Mr. Rockefeller, I proceeded to speak with Ms. Podray who confirmed that she was operating the vehicle. I noticed Ms. Podray's eyes were bloodshot red and watery. I also noticed that she was quite stiffed and slow in her movements. I asked Ms. Podray what transpired and she indicated that as she was traveling southbound a mini van struck her vehicle and then left the scene. I asked Ms. Podray if she would consent to a blood draw and she consented. Once Fire Recue arrived, she entered the Fire Rescue's Ambulance where she then declined to continue with the blood draw. After we exited the ambulance, I read Ms. Podray's Miranda Rights using Trooper Cardenas Miranda Right card. I asked Ms. Podray if she would speak with me and she declined. I then asked Ms. Podray if she would consent to the Field Sobriety Task, which she complied. I first checked Ms. Podray's eyes for Nystagmus and I found both eyes to be in lack smooth pursuit and both were with distinct & sustained Nystagmus at Max deviation. I did not found onset of Nystagmus prior to 45 degree on either eyes, nor was vertical gaze Nystagmus found. I asked Ms. Podray if she had any injuries to her eyes, legs arms or any part of her body, which would, impeded her from performing any of the Field Sobriety Task and she stated that she did not. I had instructed Ms. Podray not to begin and exercise until I advised her to. When I was explaining her how to perform the task, I was also demonstrating to her how to perform each task. I noticed that Ms. Podray was not adhering to my instructions, to the point of starting a task before told to do so. She performed the Walk and Turn as well as the One-Leg Stand. During the One-Leg Stand, she failed to maintain her right foot up for more than 30 seconds. She dropped her foot to the ground a couple times. During her Walk and Turn, I asked Ms Podray to use the shadow line reflecting from the concrete barrier wall and onto the shoulder's asphalt. I asked her if she could see the line and she stated that she could, a couple times. Ms. Podray failed to perform the task as advised. During the first try, she began well until the third step. After the third step, she failed to keep her heel to her toes leaving gap from over an inch apart. She further continued to walk for 15 steps. I allowed her to attempt to complete the task three times and all three times, she failed to perform. (Please see the Sergeant Monroig In-Car video.) After the final task, Ms. Podray was placed under arrest and Trooper Cardenas placed Ms. Podray in her patrol vehicle. Trooper Cardenas transported Ms. Podray to the Palm Beach County Jail. While at the Palm Beach County jail, Trooper Cardenas and I watched Ms. Podray for twenty minutes. During the twenty minutes, she did not place anything in her mouth, nor she gurgurtuated. Once she was escorted to the video room, Ms. Podray was read her Implied Consent. She first refused to comply, but after I read her Implied Consent's refusal section, she complied. During Ms. Podray's first sample, she blew a .145 and her second breath result was a .141.

Trooper Florangel Cardenas is the traffic Crash Investigator. Ms. Podray's vehicle was involved in a traffic crash. After the crash, Ms. Podray continued southbound on State Road 91, leaving the scene of the crash, until her vehicle became disable SB SR91 at the 85 mile marker. Ms. Podray's vehicle and the Victim's vehicle both had paint transfer on their vehicle. Trooper Cardeans cited the defendant for leaving the scene of a traffic crash and the charge was added to this Probable Cause Affidavit.

After Ms. Podray was place back into the jail cell, I began to complete my Probable Cause affidavit and other DUI documentations for the DUI Packet. Ms. Podray was then booked into the Palm Beach County jail for Driving under the influence.



Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
