On Saturday 09/24/2016 at approximately 1450 hours, I responded as a back deputy at 4601 Purdy Ln unincorporated Palm Beach Fl., Deputy SIEW ID 7587 was conducting a warrant (REF PBSO Case number 16131128) on a black male subject.

While Deputy Slew was conducting his investigation, I made contact with a white male later identified by his Florida driver's license as Timothy Catanzaro who was seating in the passenger seat on a white pickup truck bearing tag number M298DZ. I advised Timothy the reason of our presents and I explained to him the details of the investigation. Timothy was Park on the driveway at the aforementioned address. I could see Timothy was nervous by the way he was moving his hands and the sweat dripping down his forehead. I asked Timothy if there was anything illegal on his person or on the vehicle that I should know about and he paused with his answered. Timothy said he was doing his paper work inside the truck and all he was intended to do was to earn extra money.

I advised Timothy I was fully aware of the activity that was done at this location as the house where he was parked is known to be a drug house. Timothy reflected for a few minutes and hand me over a small green matches box containing 9 white rocks. He advised me he was holding it but he knew what he was doing was wrong. I recovered one small box from Timothy. Through my law enforcement training and experience, I identified the substance to be cocaine. I field tested the substance UTILIZING THE COBALT THIOCYANATE REAGENT COCAINE-PROCAINE-TETRACAIN-METHADONE TEST KIT. THE SUBSTANCE TESTED POSITIVE FOR THE PRESENCE OF COCAINE. The total weight of the Heroin was .7 grms (9 pieces of white rock).

At that time, I informed Timothy he was being placed under arrest for possession of Cocaine. He was placed into handcuffs, behind his back, which were checked for proper fit and double-locked. While in the inside of my mark patrol vehicle and utilizing my in-car video, I read Timothy his Miranda rights. On camera and post Miranda, Timothy advised me he was in possession of the suspected cocaine. He was then transported to the Palm Beach County Jail.

Base on my finding and the above fact(s), I arrested Jean Paul for violation of F.S.S. 893.13 1A1, Possession of Cocaine. I processed and packaged all seized contraband at the scene and the evidence was placed into the evidence locker at PBSO District 1 second floor. This case is cleared by arrest.
