Once in front of my vehicle, I instructed Dudley to stand with her feet together and arms down by her side. Dudley put her feet together and immediately began to sway from side to side and back to front greater than two inches. At this time Dudley refused to put her arms to her side, and asked if she had to participate in the road side tasks. I instructed Dudley of her Taylor Warnings, to which she stated she did not want to perform the roadside tasks. I then offered to Dudley if she wanted to hear the task instructions and then decide, to which she stated she did not want to participate.

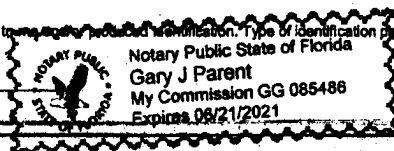

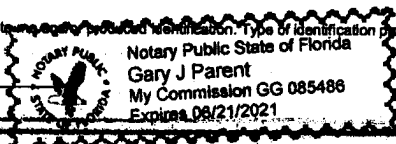

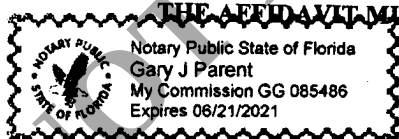
