PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 06/10/2019 I was dispatched to traffic crash at Publix located at 374 Northlake Blvd Lake Park, FL 33403. Upon arrival I made contact with the owner of vehicle two, Ms Runner-Bradden. Ms. Runner-Bradden pointed me to the witness, Mr. James Sewell. Mr. Sewell stated the tan SUV drove the wrong way down the isle (northbound lane in the southbound lanes) and while attempting a left turn struck the right rear of another car that was properly parked with the right side of the SUV. I checked the damage on both vehicle which corroborated Mr. Sewell's account of the crash. I spoke with Mr. Taylor, who was still sitting in his car with the engine running. I asked Mr. Taylors for his license, registration and insurance card. Mr. Taylor had relaxed muscle tone in his face, his eyes were red watery and blood shot and as he spoke to me i smelled the obvious odor of an alcoholic beverage on his breath as he spoke to me. He speech was slow and slurred.

OBSERVATION OF DRIVER:

I then completed my traffic crash investigation. I told Mr. Taylor that I completed my traffic crash investigation and was now starting a DUI investigation. I read Mr. Taylor his Miranda warnings, after each one I asked if he understood and he stated he did. I asked if him if he would agree to complete few roadside tasks to help me to determine if he had had to much to drink and Mr. Taylor agreed (see roadside task pg). Mr. Taylor was then placed under arrest for DUI and transported to the breath testing center at the County Jail. I observed Mr. Taylor for twenty minutes at which time he didn't regurgitate or put anything in his mouth. Mr. Taylor refused to submit to a breath test and was issued a Uniformed Traffic Citation for Driving under the influence. Mr. Taylor was booked into the County Jail for DUI.

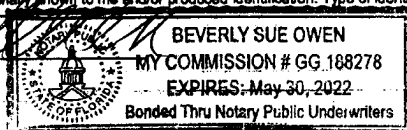

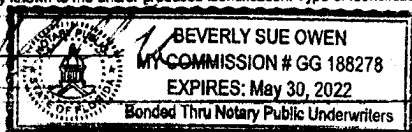
