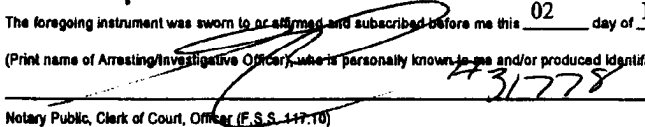

On the <u>02</u> day of <u>November</u> 20<u>19</u> at <u>2200</u> ☐ A.M. ☒ P.M. (Specifically include facts constituting cause for arrest.) On Thursday 11/02/2019, at approximately 2200 hours, I was on routine patrol in an unmarked PBSO vehicle in the area of 2171 10th Ave in the unincorporated section of Lake Worth within Palm Beach County, Florida. I was wearing my black tactical vest, which prominently displays the word "SHERIFF" in green lettering on the front and back of the vest, along with sheriff badge, issued gun belt and equipment, clearly identifying myself as a PBSO deputy. While in the commission of executing my duties I observed a White 4 door Cadillac sedan bearing FL registration PG352K enter the parking lot of the aforementioned location which known to be a high drug traffic and prostitution area. The vehicle was in in the parking lot for approximately two minutes. During this time I observed a male and female exit and reenter the vehicle. The vehicle then exited the parking lot and traveled east bound on 10th Ave. I observed the vehicle window tint to be opaque in violation of FSS 316. 2953. I then activated my emergency lights and [sirens and initiated a motor vehicle stop reference the aforementioned state statute. Upon making contact with the driver of the vehicle later identified as Ms. Cherise Gomez DOB:06/28/1991 I identified myself as a member of the Palm Beach County Sheriff's Office and requested she provide me with her FL DL and vehicle documentation. While speaking with the driver it should be noted, two other individuals were present in the vehicle. In the rear passenger side sat Mr. Dimirty Cherestal 10/26/1989 and Tacia M. Potter DOB: 10/30/1990 rear driver side. While speaking with the occupants of the vehicle as I do with every traffic stop I asked if there was anything I should be concerned about within the vehicle. At this time Ms. Potter informed me she was in possession of approximately four Xanax prescription without a prescription or order form. Ms. Potter took four yellow rectangular pills from her purse and handed them to me. The pills were marked R039 on one side and no markings on the other. The pills were secured in PBSO evidence bags and later processed the four pills were later weighted at approximately 5 grams TPW. Ms. Potter was placed under arrest, handcuffed, advised of her rights per Miranda and transported to the Palm Beach County Jail where she was charged and booked for violation of FSS 893.13.(6)(a). AT PBC JAIL MS. POTTER WAS FOUND TO BE CONCEALING APPROXIMATELY 4 grams of crack cocaine in violation of Fss 893.13(6)(a).
