On 09/20/2019 at approximately 1700 hours, I responded to 1400 W Glades Rd (Fidelity) in reference to a domestic disturbance. BRPD Communications advised that they received a call stating that a male was arguing with a female and hit her. The male party drove off in a white GMC.  Upon arrival, I made contact with the victim, Tara Ruggiere. Ruggiere stated that she and her boyfriend, Todd Billeci, who are in an intimate relationship, had gone to get lunch at Mario's. While having lunch, Billeci began to argue with Ruggiere's ex-boyfriend who works at Mario's. Ruggiere became upset and left the restaurant and walked West in the rear of the shopping plaza. She explained that Billeci approached her in the vehicle that they arrived in. Ruggiere got into the front passenger seat but shortly after decided that she wanted to leave. Ruggiere stated the Billeci grabbed the door and closed it and began to "Beat the shit out of me" from the driver seat. Ruggiere further clarified that Billeci hit her in the face with his hand and pushed her. I observed fresh cuts to Ruggiere's knees and slight redness to her face. It should be known that while speaking with Ruggiere, I could smell the odor of an alcoholic beverage coming from her person. When I asked where the cuts to her knees came from, she was not able to provide a definitive answer. Ruggiere exited the vehicle, while Billeci drove off in an unknown direction.  I then spoke to a witness, Akbarhon Avazkhodjaye, via telephone. Avazkhodjaye stated that he was leaving work at Whole Foods Market. While walking in the rear of the shopping plaza, he observed a W/M wearing a grey shirt and camo shorts in an argument with a female. Avazkhodjaye stated that the male, later identified as Billeci, "Pushed her back into the car and slammed the door on the female". Avazkhodjaye clarified that while Ruggiere had her right leg outside of the vehicle when Billeci slammed the door. Avazkhodjaye advised that the vehicle he observed was a white GMC SUV. Avazkhodjaye stated that once Ruggiere got out of the car, Billeci drove over to him and stated that

Ruggiere had just been released from rehab and he was trying to help her.

While speaking with Ruggiere, Billeci returned to the scene on foot. I then spoke with Billeci. Billeci stated that he and Ruggiere had gone to lunch at Mario's for food and drinks. While having lunch, Ruggiere became upset because Billeci and Ruggiere's ex-boyfriend were speaking about Ruggiere's drinking problem. Billeci stated that Ruggiere left in an unknown direction. He drove around the parking lot looking for Ruggiere. He found her in the rear of the shopping plaza where he stated that he was trying to convince her to get in the car. After arguing for a few minutes, Billeci drove off and parked the car back at Mario's. I observed bruising over Billeci's left eye. I asked Billeci where the bruising over his left eye was from and he stated that he received the bruise two nights ago. Later in the investigation, Billeci stated that the bruise was from his confrontation with Ruggiere today. It should be noted that the bruise did not appear to be fresh. Billeci stated that the argument in the parking lot never became physical.

Based on my investigation and statements given, I placed Todd Billeci under arrest for Simple Battery (Domestic) pursuant to F.S. 784.03(1A1) after he intentionally pushed the victim and hit her with a car door. Billeci was later turned over to Palm Beach County Jail.
