On 7/3/17, at approximately 2328 hours, I was conducting routine traffic patrol in my marked police vehicle in the area of 600 S. Dixie Hwy. I observed a 2004 red Chevy Impala (FL Tag# 959QBP) traveling south on Federal Hwy with an inoperable tag light. The light was not illuminated, thus making the license plate difficult to decipher. Utilizing my emergency overhead lights, I initiated a traffic stop at 1500 S. Dixie Hwy for this equipment violation and made contact with the driver, W/M Todd Geronemus.						
Upon making contact with Geronemus, I smelled a strong odor of marijuana coming from inside the vehicle. I advised Geronemus that he had been stopped due to an inoperable tag light on his vehicle. While speaking with Geronemus, I requested BRPD dispatch conduct an FCIC/NCIC search, which returned negative results. Officer Haggerty arrived as a backup Officer, at which point I asked Geronemus to exit the vehicle. I advised him that there was a strong odor of marijuana coming from inside the vehicle. I then asked when the last time someone smoked marijuana in the car, to which he replied "tonight." I immediately issued Geronemus his Miranda Rights from a pre-printed department issued card. Geronemus stated that he understood his rights and was willing to speak with me. Geronemus stated that there was a small amount of marijuana in the center console of the vehicle.						
Based on his statements regarding the marijuana, along with the strong odor of marijuana coming from the vehicle, I advised Geronemus that I would be conducting a vehicle search and requested that he sit on the curb near Officer Haggerty.						
During the search, I located a clear plastic bag with a green leafy substance inside. Next to the clear plastic bag was a brown package of "Raw" rolling papers. Located in the upper console, near the radio, was a black grinder with trace amounts of a green

leafy substance. Finally, I located a clear plastic container, in the center console, with what appeared to be white cardboard, in the shape of a triangle, with a yellowish waxy substance on each triangle.

I field-tested the green leafy substance with a Quick Check test kit (one use only). The field test was positive for THC by turning purple. I also tested the waxy substance with a Quick Check Test Kit (one use only). The field test was positive for THC by turning purple. I advised Geronemus that he was under arrest for possession of marijuana, possession of paraphernalia and possession of hash oil. I weighed the total amount of marijuana on a digital scale and the weight was 1.5 grams. I also weighed the hash oil inside the clear plastic container and the weight was 4.6 grams. I placed the marijuana and hash oil into evidence at BRPD. Geronemus was transported to BRPD for processing and his vehicle was removed from the roadway by Emerald Towing.

Based on the above information, Todd Geronemus is being charged with possession of marijuana, 1.5 grams, in accordance with F.S.S. 893.13(6B), possession of paraphernalia in accordance with F.S.S. 893.147(1B) and possession of hash oil in accordance with F.S.S 893.13(6A). Tracking citations (A8EJJQE, A8EJJPE and A8EJJOE) were generated for Geronemus and submitted to BRPD records. Geronemus was issued a Warning Citation (1147641) for the inoperable tag light. Geronemus was later transported to Palm Beach County Jail.
