**WALK & TURN:**

SUBJECT COULD NOT STAND STILL WHILE EXPLAINING INSTRUCTIONS, SHE KEPT INTERRUPTING ME SEVERAL TIMES SHE WAS STARTING THE TASK BEFORE SHE WAS ASKED TO DO SO & SHE COULD NOT MAINTAIN HEEL TO TOE AT ALL. SHE DID NOT TAKE 9 STEPS DOWN & SHE DECIDED TO DANCE AS SHE TURNED AROUND. DID NOT TAKE 9 STEPS ON THE RETURN.

**ONE LEG STAND:**

SUBJECT COULD NOT STAND STILL WHILE I WAS EXPLAINING THE TASK INSTRUCTIONS SHE KEPT INTERRUPTING ME SEVERAL TIMES, SHE DID NOT RAISE HER LEG (R) LEG 6 INCHES OFF OF THE GROUND, RATHER SHE BENT HER LEG HOLDING IT UP WHILE SHE COUNTED.

**FINGER TO NOSE:**

SUBJECT COULD NOT STAND STILL WHILE I WAS EXPLAINING THE TASK, & HE KEPT INTERRUPTING ME AS I TRIED TO EXPLAIN SAID TASK TO HER. SHE WOULD NOT TOUCH THE TIP OF HER FINGER TO THE TIP OF HER NOSE AT ALL WHILE PERFORMING THE TASK. SHE DID NOT KEEP HER HEAD BACK AS INSTRUCTED
