then left the residence.

Upon arrival, I made contact with Xiaoloin Tarris, who was crying and visibly upset. She told me her husband, Trebor Tarris (w/m 09/17/70), has been in a lot of pain recently due to a surgical procedure he had done. Xiaolin Tarris explained this has made Trebor Tarris irritable and worsened his anger issues. She stated they got into an argument about their dog being left outside for too long. Xiaolin Tarris told me she was standing in the bathroom and arguing with Trebor Tarris while he was in the bathtub. She told me Trebor Tarris began scooping water out of the tub and splashing it at her with his hands, soaking her and her clothes. Xiaolin Tarris told me she changed prior to my arrival, but showed me a copious amount of water covering the bathroom and adjoining bedroom floor.

Xiaolin Tarris further explained she went and grabbed her cell phone in order to call 911, which she told Trebor Tarris she was going to do. Trebor then attempted to grab her cell phone out of her hand to stop her from calling the police, but Xiaolin Tarris was able to retain the phone and dialed 911. Trebor Tarris then left the residence in his vehicle.

Xiaolin Tarris told me her sister, Xiaojia Yang (w/f 02/18/70), witnessed the incident. I attempted to speak with Yang but could not due to a language barrier.

I asked Xiaolin Tarris to call Trebor Tarris, which she did. I spoke with Trebor Tarris on the phone, and he told me he was at the nearby Panera Bread, located at 6671 West Indiantown Road. I asked him to wait there so I could go speak with him, and he agreed.

I made contact with Trebor Tarris at Panera Bread and read his Miranda Warnings, which he said he understood. I asked him what happened tonight prior to him leaving the residence. Tarris explained he was in the bathtub and his wife was arguing with him. He said he got frustrated because she wouldn't leave him alone so he began splashing water from the tub onto her. Trebor Tarris said he saw Xiaolin Tarris with her phone and she told me she was calling the police. Trebor Tarris stated he then grabbed the phone and tried to pull it away from her because he did not want her to call the police. Xiaolin Tarris did not let him take the phone and he left the residence.

Based on my investigation, the victim's statement, and the defendant's admissions, I found probable cause to arrest and charge Trebor Tarris with Simple Battery (Domestic), pursuant to FSS 784.03(1)(A)(1), and Tampering, Hindering, Delaying, or Preventing a 911 Call, pursuant to FSS 914.22(E).

I placed Trebor Tarris into handcuffs in the rear, which were double-locked and checked for proper spacing.

I transported Tarris to the Jupiter Medical Center for clearance in reference to him being in pain due to a recent surgery. After clearance, I transported Tarris to the Palm Beach County Jail without incident.


MPO Banegas issued Xiaolin Tarris a domestic violence packet.
