Details are as follows:</p> <p>I was advised by Sgt Gellin (in plain clothes) that he was approached by the offender, identified as Treigh Wells and was asked: "Hey buddy, can you spare a buck? I just moved down here and I am homeless!" Sgt. Gellin then provided Wells with one dollar in US currency.</p> <p>This information was relayed to me at which point I made contact with Wells (in full police uniform) who was described by Sgt Gellin as a white male with blonde hair riding a skateboard and wearing a backpack. It should be noted that Wells had a crumpled up one dollar bill in his right hand.</p> <p>Wells was handcuffed without incident which were double locked and checked for proper fit per policy.</p> <p>Based on the above case facts Probable Cause exists to charge Treigh Wells with Ordinance 54-147 PANHANDLING/ SOLICITATION.</p>
