PROBABLE CAUSE STATEMENT	<p>The following occurred in in the City of Riviera Beach, Palm Beach County, Florida:</p> <p>On Thursday, February 23, 2017, at approximately 9:10 pm, Officers were dispatched to 1018 Indian Trace Circle Apt 103, in reference to a very heated Domestic Disturbance. While in route, Officers were advised that the situation was escalating by Riviera Beach Police Department Communications and they were receiving multiple calls from neighbors advising that they could hear a woman screaming for her life. Upon arrival, Officer Moriello made contact with Jasidy King (05/19/1993), Phong Nguyen (05/28/2001) and Tuyet Huynh (08/19/1983). Officer Moriello observed Huynh in the rear bedroom of the apartment kneeling on the floor with a meat cleaver approximately 12 inches long cutting up various items. Huynh was ordered by Officer Moriello to put down the cleaver and have a seat in the living room of the apartment. Huynh was unable to speak very much English and required her son Phong Nguyen to translate.</p> <p>Officers were advised by Nguyen that Huyhn and her husband, Terrence King Sr. (12/21/1969), had been involved in a physical confrontation followed by Terrence King leaving the apartment with Terrence King Jr. (11/02/2013). Terrence King Jr. is the child of Terrence King Sr. and Tuyet Huynh. Nguyen did not want to give a sworn statement of what occurred, however he did advise Officer Moriello that a physical altercation did occur between King Sr. and Huyhn and that it has been an ongoing issue, advising that this happens every couple of months.</p> <p>Officer Moriello obtained a sworn recorded statement from Jasidy King and the following is a synopsis and is not to be purported verbatim:</p> <p><i>[Handwritten signature of Jasidy King]</i></p> <p><i>SCANNED</i> <i>FEB 24 2017</i></p>

PROBABLE CAUSE STATEMENT	<p>Jasidy stated that Huyhn and King Sr. had been having a heated argument in the car because King Sr. was late in picking up Huyhn from work. Jasidy stated that the argument became physical when Huyhn and King Sr. arrived home. Huyhn grabbed King Sr. by the face and began to hit him several times with a closed fist to the chest and face. Jasidy then stated that Huyhn grabbed King Sr. by the shirt and started to rip it. At that point in time, Jasidy King and Phong Nguyen stepped in between Huyhn and King Sr. in an attempt to pull Huyhn off of King Sr. Once both parties were separated, King Sr. left the residence with King Jr.</p> <p>Officer Moriello made contact with Terrence King Sr. who returned to the apartment. King Sr. was uncooperative with the investigation and refused to give a sworn statement. King Sr. did advise Officer Moriello that Huyhn became extremely angry with him because he was late picking Huyhn up from work. King Sr. stated that she repeatedly hit him with a closed fist once they returned home to the apartment. King Sr. stated that Huyhn had ripped his shirt during the altercation.</p> <p>Officer Moriello photographed King Sr., who did not appear to have any visible injuries. Officers were able to recover King's torn shirt from the garbage and it was placed into evidence by Officer Moriello.</p> <p>Officer Moriello observed a 2 to 3 inch linear scratch on Huyhn's chest that was sustained during the altercation between her and King Sr. Officer Moriello photographed the scratch and placed the photographs into evidence along with other photos taken on scene.</p> <p>Due to the totality of the investigation, Tuyet Huyhn was arrested for Simple Battery (Domestic) F.S.S 784.03 (1A1) and transported to the Riviera Beach Police Department for processing. Huyhn was later turned over to the Palm Beach County Jail.</p>
