PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I observed a White Bentley bearing Fl Tag: EHSR42 traveling North on N. County Rd. near the 300 block. The vehicle was traveling at an extremely high rate of speed. I conducted a u-turn in an effort to catch up to the vehicle. During this time I activated my lights and sirens and was finally able to stop the vehicle on the 600 block of N. County Rd. I made contact with the driver and sole occupant of the vehicle, b/f Twiggi Batista, DOB 06/08/1984.

OBSERVATION OF DRIVER:

Driver's speech was slurred, eyes were bloodshot. The driver appeared to be confused when I asked her for the license registration and insurance. Batista was fumbling through her purse while attempting to retrieve these items. While speaking with Batista the music in the vehicle was on. I requested Batista to turn off the music during which time she began pushing buttons on the gear shifter and turned on the air conditioner. While speaking with Batista outside the vehicle she began to sway. While speaking with Batista an odor of alcoholic beverage was emanating from her breath.

DRIVER'S STATEMENTS:

Batista stated that she was driving home which is in Davie. When asked where she was currently located, Batista stated that she was in Miami.

ODORS:

Strong odor of alcohol emanating from driver's breathe.

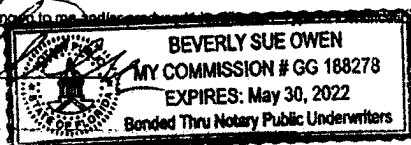

Batista was off balance during this phase and missed heel-to-toe. Batista also failed to walk on the line. Immediately after finishing the test Batista asked, "Are you going to arrest me".

Batista was swaying and using her arms to keep balance. Batista was not counting out loud and put her foot down before 30 seconds.

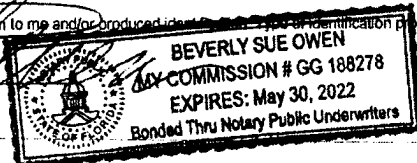

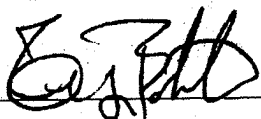
