D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

While sitting eastbound on Southern Blvd at a red light I observed the light cycle to green. As it cycled to green I observed a white truck with no bed rapidly accelerate spinning its tires and screeching its wheels. The vehicle continued to accelerate rapidly reaching a speed of 76 miles per hour in a posted 50 mile per hour zone as confirmed by my in car Stalker DSR2x Radar. Reaching the area of Benoist Farms Rd I activated my overhead lights and stopped the vehicle. The vehicle pulled to the left turn lane and I instructed the driver to turn off the truck before approaching the drivers side.

OBSERVATION OF DRIVER:

Approaching the drivers side of the vehicle I made contact with the driver. I observed him to be a white male with a plaid shirt, blue jeans, and brown shoes. While interacting with him I found him to be cooperative in providing his license and registration. He was unable to provide his insurance. While looking through his phone attempting to locate the insurance information I found his manual dexterity to be poor and he ultimately handed the phone to his passenger to attempt to locate the information. I also began to smell the odor of a unknown alcoholic beverage coming from within the vehicle. Looking inside with my flashlight I observed a cup in the center console full of a yellow liquid with a lime in it on the passenger side. I confirmed this was alcohol. Hanging from the dash was a bag with a empty bottle of Corona containing spit and chewing tobacco. In the drivers side cup holder was a clear empty cop with a residual yellow liquid. Reviewing the driver I observed his eyes to be red, bloodshot and glossy. I returned to my vehicle to confirm his drivers license and check for warrants and ultimately asked him to step from the vehicle to perform field sobriety tasks. Once outside the vehicle I still smelled the odor of a unknown alcoholic beverage coming from his breath and person.

Other Observations:

Failed to remVertical nystagmus was not present. Lack of convergence was present with the left eye failing to converge. Distinct sway while standing stationary.

WALK & TURN:

Failed to maintain instructional position departing from it and standing with his feet side by side before being instructed to return to the instructional position. Providing the remainder of the instructions he confirmed he understood them. Starting the task he took nine steps forward failing to count out loud and missed heel to toe numerous times. He performed a improper turn and failed starting walking again. Reminding him to finish the task he took nine steps

ONE LEG STAND:

Distinct sway while in the instructional position. He started the task too soon on two occasions during the instructions. Confirming he understood the task he started. Starting he failed to look at his foot as instructed and placed his foot to the ground after the count of three. After arguing with me about the task speaking vulgarly he restarted the task. Doing so he counted fourteen twice, placed his foot to the ground stopping the task after 25 seconds despite being instructed this was a timed exercise.

FINGER TO NOSE:

Distinct sway while in the instructional position. Performing the task he missed the tip of his nose numerous times and while performing the task almost fell backwards he leaned so much.

ROMBERG ALPHABET:

Distinct sway while in the instructional position. Performing the task he recited A-I then stopped, looked forward, and stopped performing the task
