

On 07/14/2018 at approximately 0058 hours, I responded to the intersection of Loxahatchee River Rd. and Senegal Dr. in Jupiter, Palm Beach County, FL as a backup unit for Sergeant Bujnowski, who had conducted a traffic stop. At the time, I was driving a fully-marked Jupiter Police Department Patrol Vehicle, I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.

Upon arrival, I observed Sergeant Bujnowski's patrol vehicle stopped, facing south, on Senegal Dr. and I observed a black 2018 Dodge Ram bearing FL tag # JNGZ91 stopped, facing south, immediately in front of Sergeant Bujnowski's patrol vehicle.

I made contact with Sergeant Bujnowski and he advised me of the following: He was conducting routine patrols in the area of Center St. and Todd St., traveling west, when he observed the aforementioned vehicle cross over the fog line on the roadway several times. He further advised the vehicle made a right turn on Loxahatchee River Rd. and almost traveled completely off the roadway. Sergeant Bujnowski advised he continued following the vehicle north on Loxahatchee River Rd. and observed the vehicle execute a left turn onto Senegal Dr., again almost traveling off the roadway. When he stopped the vehicle, he made contact with the driver, Tyler Lombardo (w/m; 05/22/1994) and observed he had bloodshot, glassy eyes, was slurring his speech, had the odor of an unknown alcoholic beverage on his person, and was fumbling with paperwork while collecting his documents (see supplement from Sergeant Bujnowski).

I made contact with Lombardo and observed he had bloodshot, glassy eyes and extremely dilated pupils. I detected the odor of an unknown alcoholic beverage on his breath, which intensified as he spoke. I also noted that Lombardo was slurring his speech while speaking with me.

D Due to my observations of Lombardo and Sergeant Bujnowski's observations of Lombardo's driving pattern, I requested he complete roadside tasks. Lombardo was hesitant and requested to know what I was going to ask him to do. I briefly explained the Horizontal Gaze Nystagmus Task, Walk and Turn, One Leg Stand, Finger to Nose, and Romberg Alphabet to Lombardo. After explaining each task, Lombardo advised he was willing to complete roadside tasks.

E During the HGN task, I observed Lack of smooth pursuit in Lombardo's left and right eyes. I observed distinct and sustained nystagmus at maximum deviation in both Lombardo's left and right eyes. Lombardo had a difficult time keeping his focus on the stimulus and would either anticipate the movement of the stimulus or look at an unknown point in the distance between the stimulus and side of my head. I also observed the onset of nystagmus prior to 45 degrees in Lombardo's right eye.

F During the Walk and Turn, Lombardo did not stand in the starting position while the instructions were being read and stood with his feet side-by-side. While walking, I observed Lombardo miss heel-to-toe, step off the line, use his arms for balance (raising them more than 6 inches from his side), turn improperly, and take an incorrect number of steps.

R During the One Leg Stand, I observed Lombardo losing his balance and putting his foot down.

O During the Finger to Nose, I observed Lombardo miss touching the tip of his finger to the tip of his nose three times.

B During the Romberg Alphabet, I observed Lombardo swaying from side to side.

A See DUI Probable Cause Affidavit for detailed breakdown of clues observed during SFSTs.

B At the conclusion of the SFSTs, I placed Lombardo under arrest for DUI. I placed handcuffs on his wrists which were checked for proper spacing and double-locked to prevent tightening. I conducted a search incident to arrest of Lombardo's person and placed him in the rear passenger seat of my patrol vehicle.

L While officers on scene were conducting an inventory of Lombardo's vehicle, a small bag with a green-leafy substance was located in the rear seat. The bag was turned over to me and I immediately recognized the contents of the bag to be marijuana, through my training and experience. I took possession of the bag which was weighed and later submitted to JPD evidence.

E I transported Lombardo to the Palm Beach County Breath Alcohol Testing Facility where I conducted a 20 minute observation period to ensure he did not ingest or regurgitate

anything orally. At the conclusion of the observation period, I requested Lombardo provide a lawful sample of his breath for the purpose of determining the alcohol content. My request had to be repeated and explained in simpler terms to Lombardo, as he did not understand my initial request.

Lombardo consented to provide a breath sample and provided two adequate breath samples of .118 and .115.

Based on the above described facts, I find Probable Cause to charge Tyler Lombardo with DUI pursuant to FSS 316.193(1) and Possession of Marijuana less than 20 Grams pursuant to FSS 893.13(6) (b).
