On 12/20/19, District 8 Street Team members executed a residential search warrant at 1277 White Pine Dr				

On 12/20/19, District 8 Street Team members executed a residential search warrant at 1277 White Pine Dr Weilington Florida, in reference to an ongoing narcotic investigation. The search warrant was drafted on 12/19/19 and approved by the honorable Judge Leonard Hanser.

Street Team members were set up in the parking lot of 1277 White Pine Dr, when Gosnell pulled in driving a black Toyota Corolla bearing Florida tag DGA-L94. I made contact with Gosnell and Identified myself. Prior to making entry into the residence, the target of focus, Tyler Gosnell, was briefed on the situation and intelligence was gathered as far as potential hazards inside the residence. Gosnell provided the pass-code to his front door, which had an electronic lock/deadbolt. Upon making entry into the residence, we announced our presence and intentions. The master bedroom which had a locked deadbolt on the door, was breached. The door leading into the kitchen was closed, due to a pitbull being contained in there. We allowed Gosnell to enter the residence, in order to take control of his dog. Once the dog was secure, the remainder of the residence was cleared.

Upon searching the master bedroom, the following items were recovered from the Craftsman tool chest which was next to the dresser: 3 grams of Cocaine which was contained in a small clear plastic bag, 11.6 grams of Cocaine which was contained inside a clear plastic bag, 8.1 grams of MDMA/Ecstacy which was contained inside a small clear plastic bag, 37 pills/5.6 grams of Alprazolam (Xanax) which was contained inside small white plastic container, 2 pills/.6 grams of Vyvanse. There was also a small .22 caliber North American Arms derringer revolver recovered from the same tool chest (S/N B70718). The firearm was later ran through PBSO Teletype and came back clear. The Cocaine tested positive using a Cobait Reagent field test kit and tested negative using a Marquis Reagent field test kit. The MDMA/Ecstacy tested positive using a Methaphetamine Reagent test kit. All recovered property listed above, was later placed into evidence.

At this time, based on the evidence recovered, Tyler Gosnell was placed under arrest, for the above listed charges. Gosnell was transported to the Main Detention Center by D/S Orozco *8057. This case is cleared by arrest. No further.
