


I (Lt Pike #1134) Attempted to stop a 32 foot Boat for violating the Manatee Speed Zone at the ICWA + Marku 60 (off Coconut LN) within the Village of Tequesta. The vessel was verified to be Doing 34mph in the Posted 25 mph zone, with Blue/Red lights and Siren (Bumps). I came along side of the vessel. I directed the operator (Tyler J. Kuehl, w/m, 9/17/87) to pull into the nearest Marina. He stated "No! you are an Asshole". After some Argument and several orders, Kuehl finally pulled into the Marina. I requested Kuehl's Driver's License and Vessel Documentation several Times with negative Results. I advised him he was under arrest for resisting/obstruction and directed him to get off the Boat. After several orders and explaining him the difference between an NTA's vs. in-custody Arrest, he continued to Resist. I had to go onto his vessel to hard-cuff and place into custody. upon Contact of Kuehl, I detected a strong odor of an unknown Alcoholic Beverage on his breath & Person. His eyes were Glassy and red-lined.
