Barrientos stated she was attacked by a female and there were two males who were instigating the attack. Barrientos stated the attack happened across the street from the Taco Bell, at the parking lot of the EyeGlass World, located at 3345 S. Congress Ave, Palm Springs, FL 33461. Barrientos stated her vehicle was parked in that parking lot and was attacked inside.  I drove to the parking lot and found the vehicle parked on the south side parking lot of the EyeGlass World. I noticed a female standing outside of the vehicle with a plastic bag in her hand. I believed the female to be the suspect described to me by Barrientos. Ofc. Leheny and I detained the female, later identified as Christalee Garcia Ruiz (DOB: 11/01/1994). Ruiz was placed in handcuffs, checking for proper spacing and securing they were double-locked.  Barrientos appeared to be calmer and I had her re-explain the incident. Barrientos stated Ruiz was her ex-giriffrend. Barrientos stated they have been separated for the last week but have been together on and off for the last two years. Barrientos stated they were driving around after she got off work from EyeGlass World at approximately 1900hrs. Barrientos stated they were the back to EyeGlass World to drop off Ruiz to walk to her friend's house. At this time they got into a physical altercation inside the vehicle. It appeared both subjects struck each other in the face based on the injuries to both subjects. Barrientos appeared to have facial injuries to the lip and mouth region and Ruiz had swelling to the left part of her face. Barrientos stated she was hit by Ruiz and did not hit Ruiz at any point.  Ruiz was being uncooperative during the investigation and when asked about the physical altercation, stated "Whatever she says goes."


