She was screaming and upon seeing me walked up to me. She identified herself as Veronica Cano (W/F, 11/01/75) and advised me that she is homeless and hangs around the Westgate area in West Palm Beach. She told me to arrest her ex-boyfriend Manuel Torres Rodriguez. According to Cano, she is a protected party and there is an Order of No Contact against Torres.</p> <p>I then met with Torres. He advised me that he is not in a relationship with Cano. She showed up at his residence unannounced. He advised that he did not want to violate the Order of No Contact and reported the incident to PBSO.</p> <p>Torres advised me that he wanted Cano to leave his property, he advised that he wanted her trespassed. I asked Cano multiple times to leave the property. She advised that she was not going to leave.</p> <p>At that time I placed Cano under arrest for one count of Trespass After Warning pursuant to F.S.S. 810.09 (2)(b). She was handcuffed behind her back. The handcuffs were double locked and checked for proper fit in accordance with PBSO policy. Cano was transported to the Palm Beach County Jail without incident.</p>
