On 01/19/17 at approximately 1528hrs I responded to Monroes adult night club located at 1000 N. Congress ave in unincorporated WPB FL, in reference to a unwanted person investigation. Upon my arrival I met with the complainant John Robilio. John informed me he is the manager for Monroes and one of his employees Viannis Ramirez-Henriquez was recently discovered doing unappropriated sexual activity inside the night club with the clients. Because of that illicit activity she as asked to turn in her uniform dress and dismissed from the business. For approximately one hour prior to calling law enforcement Viannis refused to leave the property and refused to return her uniform dress. As a last resort John called 911 one for assistance. Upon making contact with irate Viannis she refused to return the uniform and stated she did nothing wrong. Moments later I convinced Viannis to return the uniform and step outside. Once outside I attempted to explain to Viannis she is no longer an employee of Monroes. In my presence John trespassed Viannis and she refused to leave. I then explained to her in Spanish the trespassing Florida state statue and she again refused to leave the property stating she had no where to go. For the third time I ordered Viannis to vacate the property and again she refused and stated she had no where to go and demanded to be arrested. I then obtained a sworn written statement from John affirming the above incident.

At that point I placed Viannis in handcuffs to the rear of her back checking for proper fit and double locked. Based on the sworn written statement and my observations I find the suspect Viannis Ramirez-Henriquez in violation of FSS:810.09 Trespass after warning.
