NARRATIVE:

On 06/17/2019 at approximately 1900 hours, I responded to the intersection of Lake Worth Rd and Broward Ave, in the City of Greenacres, Florida 33463 within Palm Beach County in reference to a backup officer on a car crash.

Upon arrival, I met with D/S A. Norris #24996, who advised there was an examinant odor of burnt marijuana coming from one of the vehicles involved in the crash, a gold Toyota Camry (bearing FL tag# CSWM55).

I approached the vehicle and asked the driver, later identified as Victoria L Covello (W/F, 04/14/1999), for the insurance card.

While standing by the door of the vehicle, I was able to confirm the burnt odor of marijuana coming from inside the vehicle. I asked Covello, who was on the phone, to end her call because I need her to step out of the vehicle.

Covello exited the vehicle and I began to place handcuffs on her wrists. As I began to explain to Covello was she was being detained, she began to pull away from me and push me to get away, so that I could not place the handcuffs on her wrists. Covello began to yell "You don't have the right to do this," while still pushing me away from her body and hands.

D/S Norris assisted me by holding Covello's hands while I placed the handcuffs on her.

NARRATIVE CONTINUATION

Based on the facts and circumstances provided to me at this time, I determined that Victoria L Covello did commit the act(s) of Resisting Officer without Violence; by knowingly resisting, obstructing, or opposing any officer, county probation officer; parole and probation supervisor; personnel or representative of the Department of Law Enforcement, without offering or doing violence to the person of the officer; contrary to F.S.S 843.02.
