On the 19th day of June 20 19 at 1923 ☐ A.M. ☒ P.M. (Specifically include facts constituting cause for arrest.) On 06/17/2019 at approximately 1838 hrs while on patrol I responded to Lake Worth Road and Broward Ave., Palm Beach County, Greenacres, FL 33463 in reference to a crash reference case 19083497. Upon arrival I observed a white Toyota and a tan Toyota bearing FL tag CSWM55. I made contact with the driver of the with Toyota driver who advised he was not injured. I made contact with the tan Toyota driver and sole occupant W/F Victoria L Covello 04/14/1999. When I made contact at the driver side of the vehicle and immediately had the plain smell of raw marijuana based on my training and experience coming from inside of the vehicle. I asked Covello for her license. I finished the crash and advised backup D/S Falcon 28371 about the presence of marijuana in the vehicle and still needed the insurance card and confirmed the odor of marijuana present. D/S Falcon and I both approached the vehicle and made contact with Covello. D/S Falcon asked her to step out of the vehicle due to presence of marijuana. I she stepped out of the vehicle she became argumentative when D/S Falcon asked her to turn around and that she was being detained at this time. D/S Falcon applied the handcuff on her right hand Covello pulled away stating you don't have the right to do this. I held her left arm in order to get her restrained. I patted her down for weapons and searched for illicit narcotics. Her hands were placed behind her back checked for fit and double locked. I searched the vehicle for the marijuana and located a small glass vape pen in the center console and a burnt cigar with a glass tube connected to it. Both items were suspected to be marijuana/ hash oil based on training and experience. See D/S Falcon 28371 supplemental probable cause. I field tested the suspected marijuana vape pen / cigar with a Sirchie #4 test kit which confirmed a positive test for Marijuana/THC/Hash. The marijuana vape pen was weighed on scene using a digital scale, with a weight of 21.8 grams and the marijuana cigar with a weight of 4.4 grams I collected the marijuana and transported Covello back to district 16 for processing. I weighed the marijuana vape pen on a triple beam scale and confirmed the weight of 21.8 grams and the marijuana cigar with a weight of 4.4 grams. Based on the facts W/F Victoria Covello 04/14/99 was unlawfully and knowingly in actual or constructive possession of more than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6A). Also was unlawfully and knowingly in actual or constructive possession of less than 20 grams of amaterial, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(b). Covello also did unlawfully resist, obstruct or oppose *(D/S Falcon 28371), a law enforcement officer of the*(Palm beach County Sheriffs Office), in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02. (1 DEG MISD).

NARRATIVE:

On 06/17/2019 at approximately 1900 hours, I responded to the intersection of Lake Worth Rd and Broward Ave, in the City of Greenacres, Florida 33463 within Palm Beach County in reference to a backup officer on a car crash.

Upon arrival, I met with D/S A. Norris #24996, who advised there was an examinant odor of burnt marijuana coming from one of the vehicles involved in the crash, a gold Toyota Camry (bearing FL tag# CSWM55).

I approached the vehicle and asked the driver, later identified as Victoria L Covello (W/F, 04/14/1999), for the insurance card.

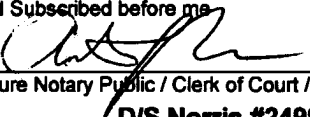
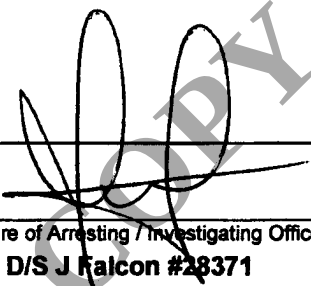
While standing by the door of the vehicle, I was able to confirm the burnt odor of marijuana coming from inside the vehicle. I asked Covello, who was on the phone, to end her call because I need her to step out of the vehicle.

Covello exited the vehicle and I began to place handcuffs on her wrists. As I began to explain to Covello was she was being detained, she began to pull away from me and push me to get away, so that I could not place the handcuffs on her wrists. Covello began to yell "You don't have the right to do this," while still pushing me away from her body and hands.

D/S Norris assisted me by holding Covello's hands while I placed the handcuffs on her.

NARRATIVE CONTINUATION

Based on the facts and circumstances provided to me at this time, I determined that Victoria L Covello did commit the act(s) of Resisting Officer without Violence; by knowingly resisting, obstructing, or opposing any officer, county probation officer; parole and probation supervisor; personnel or representative of the Department of Law Enforcement, without offering or doing violence to the person of the officer; contrary to F.S.S 843.02.
