Probable Cause

On August 5, 2018 at approximately 1300 hours, I, Officer James Brodbeck was on patrol in Palm Beach County. I observed a black Toyota Camry Florida Tag IMYK88 (Exp 1/18). The registered owner of the vehicle, identified as the driver, had a suspended Driver's License. I initiated a traffic stop at Blue Heron Blvd and Garden Rd. While stopped, the vehicle accelerated and made a u-turn in front of a silver Honda Civic, causing an accident. After checking for injuries, I detected a strong odor of marijuana coming from the Toyota. The driver, VICTORIA MONTGOMERY (DOB 1/5/1993), had a suspended DL. After receiving consent to search the vehicle, I located marijuana, THC oil in smoking pipes, as well as other paraphernalia. The subject was placed under arrest at 1417 hours and transported to the Palm Beach County Jail.


