


Banegas #328 that he was on a call at 815 W Indiantown Rd. (Circle K) when he smelled an odor, which he believed to be marijuana, coming from a red Ford (FL Tag: ECSH34).</p> <p>Once I arrived at the Circle K, I observed the red Ford (Ofc. Banegas #328 had described) leaving the parking lot of the business. The vehicle left the business and drove northbound on S Whitney Dr., the vehicle then made a left turn westbound onto W Whitney Dr., the driver of the vehicle then made a right turn to travel eastbound on Reo Dr., then an immediate left turn to travel northbound on Daly Dr. I then activated my emergency lights from my marked patrol vehicle, and conducted a traffic stop on the vehicle. The vehicle came to a final stop at 408 Daly Dr.</p> <p>As I approached the vehicle I could detect an odor, which from my training and experience was to be marijuana coming from the vehicle. I made contact with the driver of the vehicle W/M Vincent Cicciarelli 2/8/98, the front seat passenger W/M Devin Hazelton 3/12/99, and a subject who was in the bed of the truck H/M Nicolas Bisono 4/30/98. I informed the subjects why I stopped them and then advised them that I also smelled the odor of marijuana coming from the vehicle. I asked Cicciarelli and Hazelton, if there was anything illegal in the vehicle and they both told me no. I then asked all 3 subjects to exit the vehicle and conducted a pat down and search of their person, due to the odor of marijuana coming from their person.</p> <p>While searching Cicciarelli I found a nugget of a green leafy substance, from my training and experience was to be marijuana. Cicciarelli immediately said he forgot that was in his pocket. I then conducted a search of the vehicle and found a baggie of a green leafy substance in the driver's side door.</p> <p>I then made contact with Hazelton, and read him his Miranda Rights from my department</p>

issued Miranda Rights card, which he stated he understood. I asked him if who the marijuana belong to that was found in the door. Hazelton said the marijuana belong to him and Cicciarelli. I then asked him who bought the marijuana and Hazelton stated he bought the marijuana for him and Cicciarelli.

I then made contact with Cicciarelli, and read him his Miranda Rights from my department issued Miranda Rights Card, which he stated he understood. I asked him about the marijuana I found in his pocket and he stated he forgot it was in his pocket.


Based on my investigation I have Probable Cause that Vincent Cicciarelli and Devin Hazelton was unlawfully and knowingly in actual or constructive possession of less than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13 (6) (b) .

Both Cicciarelli and Hazelton were placed into handcuffs which were double locked and checked for spacing. Both were placed in the back seat of my patrol vehicle and were transported to Jupiter Police Department for processing. Hazelton was later released to his mother W/F Regina Kreis 5/12/73, and Cicciarelli was transported to Palm Beach County Jail for Booking.

The green leafy substance that was found on Cicciarelli and found in the vehicle field tested positive for THC and was placed into evidence at the Jupiter Police Department.

There is no further information at this time.
