PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Thursday, April 12, 2018, at approximately 15:01 hours, I was dispatched to assist CSA4 Vera #4222 on the traffic accident she was working on (see case#18-061716) where the driver of V1, identified by his Florida license, Vincent Laudano was showing signs of impairment. Upon my arrival I made contact with CSA4 Vera, who stated as she spoke with Laudano, she could smell a strong odor of alcohol emanating from Laudano's breath.

Next, I made contact with Laudano, who was standing by his vehicle. I advised him that the CSA4 Vera's crash investigation was completed and a DUI investigation would be conducted by me. As I was talking to Laudano I could smell a strong odor of an unknown alcoholic beverage emanating from his breath. I had Laudano to walk over to a flat, dry, portion of the roadway. Laudano wobbled as he walked and his balance was very poor. Laudano advised that he did not sustain any injuries from the crash, however he had an accident four months ago where he fell from a roof and hurt his back and he was diabetic. I had PBCFR to check Laudano's blood sugar and the result was normal.

OBSERVATION OF DRIVER:

As I was talking to Laudano I could smell a strong odor of an unknown alcoholic beverage emanating from his breath. I had Laudano to walk over to a flat, dry, portion of the roadway. Laudano wobbled as he walked and his balance was very poor. Laudano advised that he did not sustain any injuries from the crash, however he had an accident four months ago where he fell from a roof and hurt his back and he was diabetic. I had PBCFR to check Laudano's blood sugar and the result was normal.

Laudano appeared impaired, had glassy reddened eyes, slow dexterity, flush face, slurred speech and had the odor of an unknown alcoholic beverage about his breath.

DRIVER'S STATEMENTS:

I asked Laudano if he had anything to drink earlier today and he replied by saying he had three bottles of beer while having lunch today at approximately 11:00 hours.

ODORS:

Alcoholic beverage upon his breath.




