## Probable Cause

JAN 1 AM 4:24

On January 1, 2018 I was on routine patrol in Palm Beach County in my marked patrol car. I responded to the scene of a driver asleep behind the wheel of the car on I-95 northbound exit ramp to Donald Ross Road. I arrived and observed a dark colored Honda sedan in the right lane of the exit ramp and blocking the right lane of the eastbound Donald Ross lane. I approached the vehicle and observed that it was occupied by a male driver. The driver was slumped over the steering wheel of the vehicle with his foot on the break and car in drive. The driver appeared to be asleep and did not respond or wake up when I attempted to knock on the window. Once the driver began to wake up he began to drive forward I then had to break open the driver's side window. This was done so that I can place the car in park and prevent it from going further into the intersection. I then requested that the driver step out of the vehicle and walk towards my patrol car. As he stood in front of me I observed that he had the odor of an unknown alcoholic beverage emitting from his breath. I also observed that he had orbital sway, blood shot glassy eyes and slurred speech. He stated that he was not going to answer questions and that he was "pleading the fifth." I then requested that he conduct roadside exercise and he refused. I then explained to him Taylor Warnings and the consequences if he didn't do the exercises. He stated that he was "pleading the fifth." He was then placed into handcuffs and under arrest for DUI. The driver was identified by his FL DL as Vincent Lanciano. He was then secured and transported to the county jail. Once I arrived at the county I conducted a 20 minute observation. At no time did he regurgitate or take anything by mouth. At approximately 0335 I requested that he provide a lawful sample of his breath and he refused. Implied consent was read and he stated that he understood. He again refused to provide a sample. He was then booked into the county jail.


