On February 13 2017hrs I was dispatched to Brendy's Ice Cream at 12369 Hagen Ranch Rd in unincorporated Boynton Beach reference a domestic assault.

Upon my arrival I met with the victim Patricia Groh. Patricia was sitting in her vehicle hyperventilating and crying. I had her take slow breaths which did not seem to be working. I was able to get a paper bag and had her breath into it. This seemed to help a little but then Palm Beach County Fire Rescue 44 arrived to check Patricia out.

After Palm Beach County Fire Rescue was able to get Patricia to calm down she gave me a statement. Patricia stated she arrived to work to find her ex-husband Wahid Mahmood there. He does work at the Ice Cream Store. A verbal argument over money began between the both of them. Wahid became more upset and slammed the cash register. Patricia told him not to slam the cash register. They went in the back room and the argument continued. Patricia stated Wahid became more upset and swung at her hitting her in her right arm. I checked her arm and saw a red mark on the inside of where the arm bends. She stated she called 911 and went out to her vehicle to wait.

I spoke with their son Austin Groh. Austin stated he stated his parents were in a verbal over finances and the business. He said Wahid became upset and slammed the register. They went in the backroom and the argument continued. Austin said he witnessed his father swing and hit his mother. Austin said his mother left the store.

I met with their other son Brenden Groh. Brenden said he was outside when the altercation took place but knew they were arguing over finances. He stated he did not see his father strike his mother.

I met with Wahid Mahmood. I read him his Miranda warnings form a Miranda card on camera. After reading Wahid his rights he stated he was willing to talk with me. Wahid stated Patricia came to work upset. They got into an argument over finances. He stated he never hit Patricia and would never hit her.

After talking with everyone involved I find there is probable cause for the arrest of Wahid Mahmood for simple battery domestic.

Wahid Mahmood did actually and intentionally touch or strike Patricia Groh against the will of Patricia {or} did intentionally cause bodily harm to Patricia Groh contrary to Florida Statute 784.03(1)

I gave Patricia a case information form and a victim's rights brochure. Pictures were taken of Patricia and the scene. Domestic advocate level 2 was notified. Palm Beach County Fire Rescue 44 arrived on scene and checked Patricia out.
