As I approached the vehicle I observed Staples sitting in the drivers seat with his hand in his lap with the vehicle not running. I asked Staples for his proof of insurance and registration. When asked multiple times, Staples could not produce his insurance or registration. Staples handed me a receipts and business cards. Staples had excessive movement and fumbling with objects in hand. Staples had blood shot eyes. There was an unknown odor of alcohol coming from the vehicle.

WALK AND TURN:

I had Staples stand with his hands to his side and his right foot in front of his left foot. During the instructional phase Staples swayed in an orbital pattern. Staples started with his right foot in front of his left and took 9 steps forward. On all 9 steps, Staples missed touching heel to toe and staggered off the line. During all 9 return steps, Staples missed touching heel to toe and staggered off line.

CAN NOT DO, WHY? _____

ONE LEG STAND:

I had Staples stand with his hands to his side and feet together. During the instructional phase, Staples stood with his right foot slightly raised and toes pointed down. Staples swayed in an orbital pattern. Staples counted to three one thousand and put his foot down. Staples tried lifting his foot two more times before losing his balance.

CAN NOT DO, WHY? _____

FINGER TO NOSE:

I had Staples stand with his hands to his side, feet together, and head tilted back eyes closed. During the instructional phase subject swayed in an orbital pattern. Staples failed to return his arms to his side on all commands. Staples failed to keep his eyes closed. Before being advised to start the task, Staples placed his right middle finger on his nose and left it there until I told him to start the task. When advised both right and left fingers tips did not touch his nose but touched the middle of his fingers. Staples did this all six times

CAN NOT DO, WHY? _____

ROMBERG / ALPHABET:

I had Staples stand with his hands to his side, feet together, head tilted back but did not keep eyes closed. During the instructional phase subject swayed in an orbital pattern. Staples stated he knew the English alphabet and could recite his A,B,C's. Staples started A,B,C,D and restarted with A. He completed A through O when he restarted at A again.
