PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Eyewitness provided sworn-oral statement stating he saw Hawley behind the wheel of his vehicle, crash into another vehicle twice, began to drive off. Eyewitness stopped Hawley and reported incident to Gardens Mall Security. Mall Security advised they have surveillance footage of the incident.

OBSERVATION OF DRIVER:

Hawley had bloodshot eyes, slurred speech/mushed-mouthed and was unable to keep his balance/ stumbled around. Hawley used the vehicle to keep himself propped up. Hawley began to cry at the crash scene. Hawley attempted to complete SFST, however due to his level of intoxication, he was unable to keep balance, unsteady, and needed assistance to keep balance when away from vehicle. Out of concern for his safety the tasks were suspended. Hawley had significant mood-changes during the encounter (calm, emotional, cooperative, aggressive, argumentative, belligerent).

DRIVER STATEMENTS:

Hawley stated he was drinking at Brio Tuscan Grille. Hawley did not remember hitting another vehicle. Hawley stated he is "drunk" and needs a [drunk] tank and to attend AA. While in BAT center, Hawley stated he was probably over the .08 limit and refused to complete the test (post-Implied Consent).




