<p>On Tuesday, February 14, 2017 at approximately 2000 hours, Ofc. Gordon and I responded to the Brazilian Court Hotel located at 301 Australian Ave, Palm Beach, in reference to an intoxicated person causing a disturbance. Upon arrival, we made contact with Warren J. Malone (W/M, DOB 7/11/1955). Sgt. Alber and Sgt. Walley also arrived on scene. Malone was intoxicated, with the smell of alcohol on his breath, and he admitted to have been drinking alcohol. He was yelling and causing a scene in front of staff and customers of the hotel. His name was checked through Dispatch, and they advised that Malone had been issued trespass warning #66733 earlier in the day from the Brazilian Court.</p> <p>Malone was told he was under arrest for the trespass after warning charge. He became agitated, and attempted to pull away from the officers on scene. Malone was secured and placed under arrest at 2012 hours. Brazilian Court manager Alejandro Martinez (W/M, DOB 9/18/1990) signed an Affidavit of Prosecution indicating he would prosecute on behalf of the Hotel. Malone was charged with Trespass After Warning, Disordely Intoxication, and Resisting Arrest Without Violence.</p>
