


<p>On 08/27/16 at 1300 hrs, I responded to 5700 West Glades Road (Macys) in reference to a Retail Theft. Upon arrival, I met with Loss Prevention Associate Elecia Lopez. Lopez advised she observed an unidentified male enter the Men's department. The male was later identified as Wesley Hurki by his Brazilian Driver's license. Hurki selected two pairs of Polo brand boxers along with a white Polo brand shirt and walked with them into the fitting room. Lopez alerted Security Officer Donald Michaud that the male had entered the fitting room. A short while later, Hurki exited the fitting room with only a pair of white shorts in hand. Michaud searched the fitting room that Hurki used and there were no items left behind. It appeared that Hurki concealed the items into the backpack that he was carrying.</p> <p>After exiting the fitting room, Hurki began to walk toward the Polo Underwear Department where he selected four packs of underwear and multiple pairs of boxers. After selecting those items, Hurki went back to the same fitting room that he used previously. A short time later, Hurki exited the fitting room with no merchandise in hand. The fitting room was then checked by a sales associate in the Men's department. It was confirmed that there was no merchandise left behind in the fitting room. Hurki then continued to the Men's Active Wear Department and was seen selecting some slim grey boxers. After selecting those items, Hurki entered the fitting room of that department. A short time later, Hurki exited with no items in hand. Lopez checked the fitting room and there was no merchandise left behind.</p> <p>Constant surveillance on Hurki was maintained through floor surveillance and CCTV. Hurki then proceeded to exit the store (via North exit) passing all points of sale making no attempt to pay for the merchandise. Hurki was apprehended while he was outside of the store by Lopez and Michaud and Lopez identified herself as a Macys Loss Prevention associate. Hurki was escorted to the Loss Prevention office. The items were recovered from Hurki's shopping bag by Lopez. The total cost of the items was \$425.25.</p>
