Ofc Gannon stopped a 2015 silver Mustang bearing Fl tag#DIHD58 after the vehicle was involved in an accident. The Mustang left the location of the accident which was 3999 N Federal Hwy without giving any of the required information when involved in an accident and drove south bound on N Federal Hwy. The other party involved followed the vehicle and was able to give a tag and location to the vehicle. Ofc Gannon stopped the vehicle due to the vehicle leaving the scene of an accident. See Ofc Gannon report for further details.</p> <p>Ofc Genden was on scene as well handling the traffic crash. Ofc Genden advised that he met with William Fera the driver and lone occupant of the Mustang and made the following observations: Fera had blood shot glossy eyes, slurred speech, odor of an alcoholic beverage emanating from his person and Fera told him that he had three Vodka drinks earlier in the day. Ofc Genden advised that he couldn't locate his Florida driver's license when he asked Fera for it. While waiting for Ofc Genden to finish with his investigation, I asked Fera what happened in the accident and Fera stated that he rear ended another vehicle. Fera advised that he didn't believe there was any damage so he left the scene and started driving home. I then asked Fera if he had a driver's license and he was unable to locate it from the cards and money that he had in his hands. I then asked him if he had a Florida driver's license at which time he pulled out his wallet and located his Florida driver's license. Ofc Genden advised Fera that he had completed his investigation and was now turning it over to me. See Ofc Genden report for further details.</p> <p>I then met with Fera and read him his Constitutional Rights in the presence of Ofc Gannon and Fera advised that he understood and would answer my questions without an attorney present. <p>speech was slurred, his eyes were blood shot and glossy and he had a strong odor of an alcoholic beverage emanating from his person. Based on all the above information and my observations I asked Fera if he would submit to roadside sobriety tasks to dispel my alarm that he was under the influence of alcohol and Fera refused. I then informed Fera of his Taylor Warnings and asked him to conduct the roadside sobriety tasks again and he still refused. I then asked Fera to exit the vehicle so I could place him into custody. As Fera exited the vehicle he stumbled and used the driver side door to keep his balance and not fall. I then had him walk to the rear of the vehicle and he appeared to be unstable while walking. I asked him if he was okay or hurt and he stated no. I then placed him into custody for DUI.</p> <p>I then transported Fera to BRPD where Ofc Rafalko responded as my Breath Test Operator. Ofc Rafalko and I conducted the 20 minute observation and then he was taken into the BAT room. Fera refused to provide a breath sample. I read him Implied Consent Warnings, which he advised that he understood and still refused to provide a breath sample. I also read Fera his Constitutional Rights which he advised that he understood and answered my questions. See DUI influence report.</p> <p>William Fera is being charged under F.S.S. 316.193(3c1) for DUI. A copy of the original in car video tape of the above Road Side Tasks was submitted into BRPD evidence. Fera was taken to Boca Regional Hospital to get medically cleared. 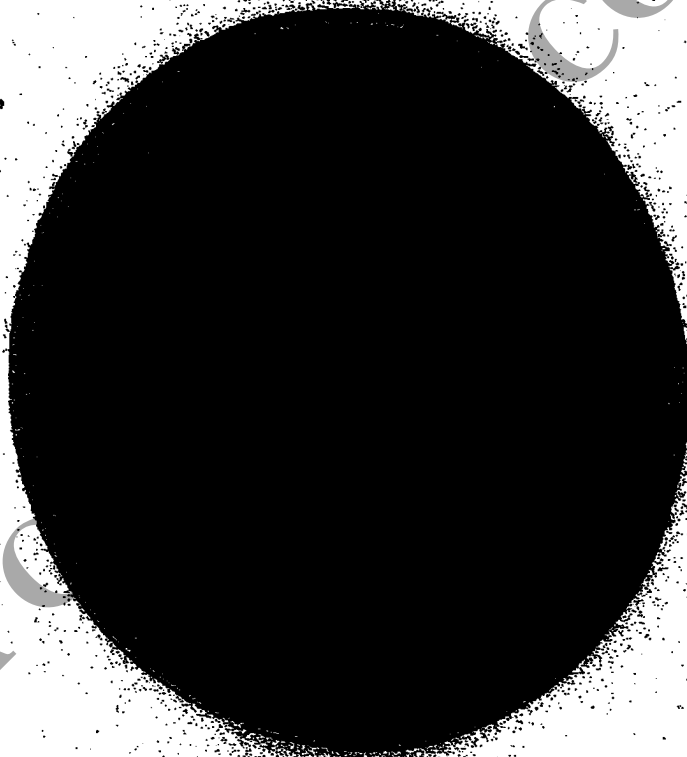
