On 12/29/17 at 2000 hours I met with William and Carrol Gaudio [REDACTED] Delray Beach in reference to a delayed domestic dispute.

Upon initial contact I first met with Carrol who opened the front door. Carrol advised that she and her husband William had been in an argument and that he slapped her in the right side of the face. Carrol stated she was arguing with William because he doesn't support her and that she didn't feel loved. After the argument became more heated, William got very aggressive and laid hands on her. Carrol suffered a red mark on her face and no serious injuries. Carrol also denied to be treated by paramedics.

I then made contact with William who advised that he and Carrol were in fact in a heated argument and that she kept badgering him. William then advised that he did strike Carrol in the face and push her. William stated "I didn't hit her to hurt her I did it to shut her up". William advised he felt bad and later realized he was wrong for doing what he did. Upon William's spontaneous utterance and admission to hitting Carrol, I placed William under arrest and transported him to the county jail for booking and processing without further incident.
