On the above date and time I responded as a back-up Deputy for D/S Sentmanat #24968 who had conducted a traffic stop on a gray Chrysler 300 bearing FL Tag: BWIF34 at 7201 Lake Worth Rd, A Lake Worth, FL 33467 (Beef & Ale). D/S Sentmanat made contact with the driver as I positioned myself on the passenger side. D/S Sentmanat stated that he smelled the odor of marijuana emitting from the vehicle and that he was going to have the occupants exit and conduct a search of the vehicle. D/S Sentmanat first had the driver W/M Robert Reynolds (2/20/95) exit the vehicle and conducted a search of his person.

I then had the front seat passenger W/M William Hayden (11/1/94) exit the vehicle and I conducted a search of his person. As I was conducting the search I located a small clear pink bag containing a white powdery substance in his front right change pocket, that through my multiple drug arrests identified to be cocaine. Hayden was secured in handcuffs that were double locked and checked for fit and was placed into the rear of my marked patrol vehicle for the remainder of the traffic stop.

After D/S Sentmanat advised me that his search was complete he issued Reynolds traffic citations for the infractions. The cocaine was weighed which produced a total package weight of .3g and was field tested using a Sirchie #7 Cobalt test kit and a Sirchie #1 Marquis test kit, both tests produced a positive result. Hayden was advised that he was under arrest for Possession Of Cocaine pursuant to F.S.S. 893.13(6)(a). Hayden was later transported to the Palm Beach County Jail for booking.
