During task Driver, failed to make heel to toe contact, stopped to steady himself, stepped off the line, used arms for balance, and even asked for instructions after making the first pass.

One Leg Stand

During task, Driver was only able to raise left foot for a brief period, before I terminated this task. The reason for terminating this task was after Driver placed his foot on the ground and almost fell aggressively to the ground.

During task, Driver couldn't touch the tip of his nose with the tip of his finger 4 out of 4 attempts, Driver had to be instructed to place his hand(s) back to his side after each request. The cadence requested was: Left, Right, Left, and Right. This task was cut short due to the downpour of rain.

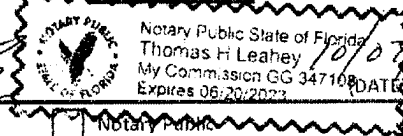

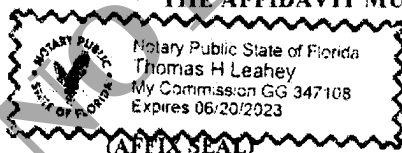

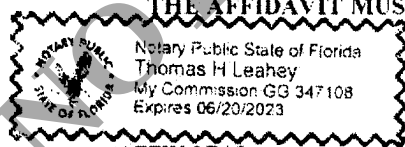
