

<p>While on patrol, I responded to 12220 Alternate A1A at Texaco gas station located in unincorporated Palm Beach Gardens, FL in reference to a traffic stop that was conducted by D/S Gareau #17740. As I was en route to back up D/S Gareau, he advised over the main radio channel that he needed back up units code 3 (emergency lights and sirens activated) for uncooperative subjects that he was dealing with while he was conducting a lawful traffic stop.</p> <p>Upon my arrival, I observed a white male wearing a gray and red striped shirt with blue cargo shorts video recording the incident. The male was standing outside the business next to the gas pumps located on the north side of the gas station with his cell phone in his hands video recording. Myself and other deputies on scene never approached the male or spoke to him until he walked closer to the marked patrol vehicles. The male was stumbling as he walked back over towards the business and was talking with two other males. As I watched the male from a distance he then staggered walking back over towards the vehicles, he held up both hands and made a gesture with his hands as if he were holding a cell phone or camera to record the incident. The male's behavior made it apparent to me that he may have been impaired and delusional, actually believing that he was videotaping although he had nothing in his hands. While D/S Gareau was conducting his investigation, myself and D/S McCullough were observing the other males outside the business for officer safety reasons. D/S McCullough then walked into the business and spoke with the manager of Texaco who advised the white male outside wearing the gray and red striped shirt has been loitering around the business acting weird. The manager wanted the subject trespass from the business. At this time, D/S McCullough approached the white male and asked for his identification. The male cooperated and produced his FL DL was identified as William Michael Annis. William had a strong odor of an alcoholic beverage coming from his person as he was speaking. Due to William's staggered walk along with the other indicators of impairment that were observed, D/S McCullough had William sit on a curb outside the business. William was slurring his words and stated that he wanted his attorney. It was unknown why William asked for his attorney as he was not under arrest and was making no logical sense as he continued to slur his words. At this point, I was concerned for William's safety as he stated he had a vehicle but could not tell me where it was.</p> <p>Based upon the above, I believed that William was substance abuse impaired and had lost the power of self-control with respect to his impairment. I also believed that if no intervention had taken place, William would likely suffer injury to himself due to his level of impairment. Additionally, I believed that his irrational statements and delusional behavior made him unable to appreciate the need for substance abuse treatment or services. William met the criteria for a Marchman Act and thus gave me the authority to detain him while the trespass warning/investigation continued.</p> <p>While D/S McCullough walked away to his vehicle, William Annis stood up from a seated position and called someone on his phone. I gave William a verbal command to hang up the phone and sit back down which he did not comply. I then asked William a second time to hang the phone up and sit down which he did not comply and continued talking to whoever was on the phone. I told William a third time to sit down or he is going to be placed under arrest which he still did not comply. At this time, I grabbed his right arm and attempted to place him into handcuffs but William tensed his body and pulled his arm away. I attempted to gain control of his right arm by placing it behind his back and at this time William sat on the ground still pulling his arm away. I finally gained control of his right arm placing it behind his back as other deputies helped to gain control of William. William was placed into handcuffs and under arrest for resisting with out violence violation F.S.S 843.02 based upon his non-compliant and resistant behavior. He was transported to County Jail by PBSO transport unit.</p>
